

Sworn Witness Statement / Affidavit for Commissioner Everton Jeffers

Royal Police Force of Antigua and Barbuda

Re: Criminal Conspiracy, CSAM Distribution, Financial Crimes, Murders, Court Tampering, Defamation, Harassment, Financial Exploitation of a Disabled Person, Weaponization of Disability, Unlawful Judicial Delay, and Extortion Racket in ANUHCV2025/0149 and Related AG / Justice Rene Williams Court Matters

I, **Alkiviades “Alki” Andrew David**, of SwissX Island, Antigua & Barbuda (and formerly of the United Kingdom), do solemnly, sincerely, and truly declare and affirm under oath as follows:

1. I come before the Commissioner with the full support of the Prime Minister of Antigua & Barbuda, the Right Honourable **Gaston Browne**. He has been nothing other than a G — fully supportive — and with his leadership we were able to successfully navigate our way through the **Southern District of New York** proceedings. As appellant, I secured a clear win in the **Alpha Nero** defamation matter, where the court ruled that the same network defamed both me personally and the sovereign nation of Antigua & Barbuda. This victory directly confirms the defamation campaign against our country and exposes the network’s pattern of using litigation, media, and false narratives to attack both individuals and small nations that resist its influence. This was achieved **without any help whatsoever from the Attorney General**. On the contrary, the Attorney General has worked consistently against the Prime Minister and against the interests of this country. In particular, in the case of **Diddy (Sean Combs)**, the Attorney General is alleged to have sheltered Diddy’s plane secretly in Antigua while arrests and raids were taking place on his homes in the United States. The Attorney General is also a direct competitor of mine in the entertainment business.
2. I am a media and entertainment business executive with deep, personal involvement across the global entertainment industry. This is my world. I have acted in major studio productions and independent films, produced and directed films, built FilmOn through extensive content acquisitions (including the CineBx Library and CinemaNow), and developed world-famous hologram technology. My insider experience spans talent agencies, studio operations, independent filmmaking, and content management from acquisition to distribution. These activities gave me forensic, up-close knowledge of how the entertainment business truly operates — and how a criminal network has infiltrated and corrupted it.
3. I am a direct member of the **Leventis-David family**. My father, Andrew A. David, was the largest Coca-Cola bottler in the world and the key man behind the Leventis business empire, with major holdings in Coca-Cola HBC AG and longstanding ties to Sony Columbia and TriStar Pictures. My ex-brother-in-law is deeply embedded in the Coca-Cola network. The Leventis-funded businesses and investments I was involved with were in significant part built and operated by a group of pedophiles, many of whom are directly related to me. I am now exposing this network.
4. **It all began with the family trust in London**. The disputes, betrayals, and coordinated attacks against me originated from conflicts over this London-based family trust, in which I hold (or held) beneficial interests. My sister has been directly involved in trust matters that I allege suppressed my rights and diverted family assets.

5. In the late 1990s and early 2000s, I co-founded **Independent Models** with **Barrie Duncan Heath** (Duncan Heath of Independent Talent Group). Duncan Heath, **Mike Pappas**, and I had overlapping dealings in modeling, entertainment, and private-equity vehicles (including WW Entertainment Limited), documented in early emails regarding U.S. investments for the Leventis side. Through Duncan Heath's agency, I secured acting roles including **Bambas** in **The Bank Job** (2008), appearances in BBC's **Spooks** (MI-5), **Hotel Babylon** (as Mr. Pappas), **Waking the Dead**, **Trial and Retribution**, and others. I also produced, directed, wrote, and acted in independent films such as **Fishtales** (2007, as Captain Mavros) and **The Freediver** (2004, as Hector), gaining a profound eye-opener into independent filmmaking. My work building **FilmOn** provided forensic insight into content management from independent to studio level.
6. These relationships were weaponised into a larger criminal network that includes **Ron Burkle** (Yucaipa Companies / Soho House & Co.), whose operations intersect with my family's Leventis/Alpheus Capital holdings; **Robert De Niro** (via the Nobu development in Antigua & Barbuda); **Dr. Carole Lieberman** (my former psychiatrist from Beverly Hills in the 1990s, who is part of this network and publicly recorded as connected to NXIVM, including her advocacy and use of drugs such as scopolamine and related substances — the criminality of NXIVM is fully on the public record), **Daniel Saltzman**, and **Lauren Saltzman** (NXIVM ties, with my 1990s LA introduction via Daniel Saltzman); **Daphne Barak** (B-A-R-A-K, related to Ehud Barak and directly linked to Harvey Weinstein and Jeffrey Epstein), **Corey Feldman**, **Gary Shoefield** and **David Nussbaum** (former Hologram USA executives involved in the theft of my IP), **John Branca**, **Oprah Winfrey**, **Anthony Pelicano** and his network (including **Danny Kapon Sr.**, described as Pellicano's killer / hitman, whose son **Daniel Kapon** of Greek origin is one of the victims in this network), **Sarah Bronfman**, my sister, **Clare Bronfman**, and connected entities. The Bronfman sisters (Sara and Clare) poured **hundreds of millions** into NXIVM and Keith Raniere, much of it allegedly lost or misappropriated. The criminality of NXIVM, including the grooming, branding, and sexual abuse of victims such as **Camila** (who was 15 when the abuse began and whose Dropbox materials and explicit communications with Raniere are on the court record), is fully documented in federal prosecutions. My own relatives participate in Antigua & Barbuda's Citizenship by Investment Programme (CIP) and hold significant assets here, which the network has exploited. I specifically direct the Commissioner's attention to the Carrington emails: **Rovier Carrington** reached out to me, supplied extensive victim files and evidence of the network's activities, and these materials (including his submissions asking for help through the network) are now included in the Antigua filings and form part of the record.
7. This network operates as an industrial-scale criminal organisation responsible for the mass distribution of **Child Sexual Abuse Material (CSAM)** through the **Warner Music Group / Universal Music Group** ecosystem, including direct ties to the **Diddy (Sean Combs)** network and associated Hollywood structures. It has committed large-scale financial crimes against me, including deliberately crashing my IPOs and stealing my world-famous hologram intellectual property (developed through Hologram USA, featuring Whitney Houston's hologram performances and other iconic artists). Key insiders involved in these crimes include **Gary Shoefield** (fired for gross incompetence

and stealing proprietary information) and **David Nussbaum**. The network created a deliberate illusion of wrongdoing using TMZ and Gloria Allred, flooding the media with false narratives, text messages from girls (some of whom were part of the exploitation), and coordinated attacks to destroy my reputation and businesses. Corey Feldman has long positioned himself as a speaker against Hollywood pedophilia, yet his repeated pattern is that he receives a show or platform and then falls silent — this is precisely how the extortion racket and compromise system operate, trading access and silence for what you know. The operation is protected by elite legal, media, and financial operatives who have systematically targeted me, my businesses, and my family. I believe **John Kyriakou**, former chief of the CIA desk in Athens, Greece, would be willing to come forward as a witness. He speaks regularly of this cartel's strangulation on the world's economic order.

8. The abuse within the family provides further testimony as to who this network truly is. My cousin **Nicola Leventis** (also referred to as Nick Leventis in some family contexts), adopted into the broader Leventis family of **Gillian Harry Leventis**, has given accounts of being sexually molested and raped by his mother throughout his life. These accounts, along with the involvement of my sister and **Sarah Bronfman** as part of the NXIVM network, illustrate the depth of the pedophile element embedded in the family and the wider syndicate.
9. Further evidence of the network's tactics is seen in the wrongful accusation in Greece circa 2022 against my two cousins, the Leventis twins **Evagoras** and his brother. They were falsely accused, and a media storm was deliberately generated to destroy their reputations. I was assisted in quelling that media storm by **John Kyriakou**, former chief of the CIA desk in Athens, Greece. Eventually the boys were fully acquitted of any wrongdoing, but the media effort succeeded in damaging their reputations to some degree. This episode demonstrates the network's willingness to weaponise false accusations and media campaigns against members of my family.
10. I suffer from a severe **Traumatic Brain Injury (TBI)**, a permanent and disabling condition that I have had to learn to live with and manage every day. This disability has been repeatedly weaponised against me by the network — including attempts to medicate and sedate me against my will in order to discredit, control, or silence me. Despite these ongoing abuses and attempts to exploit my TBI, I have not been broken. I stand here today, clear-minded and reporting these crimes as a survivor who continues to fight for justice.
11. While physically present in Antigua & Barbuda, I was repeatedly harassed and targeted by **Daphne Barak** and **Corey Feldman**. They made repeated attempts to come to Antigua, enticed me, and extracted money from me while I was in a vulnerable and disabled state — including a specific payment of **£8,000 via Revolut** to Daphne Barak. The emails and Revolut payment records between myself and Daphne Barak further evidence this exploitation. This conduct represents a direct exploitation of my disabilities, including my severe TBI, and forms part of the broader pattern of abuse by the network. As a disabled person, I demand full disability justice for these predatory actions committed on Antiguan soil.

12. The victims of this criminal organisation are many — **in the dozens** — and a large number of them are willing to come forward and give testimony. Many are already on the public record in the courts here in Antigua and in London, and their statements, victim files, and supporting evidence (including those supplied by Rovier Carrington) form part of the Antigua filings. One such victim is **Daniel Kapon** of Greek origin, whose father **Danny Kapon Sr.** (Pellicano's killer / hitman) is tied to the network's enforcement and intimidation apparatus.
13. Other victims include **Daniel Capone** and his mother **Allison Doe**, who are assisting the **FBI** and **Dallas PD** in investigations of related murders and suspicious deaths, including that of **Aaron Cain McKnight** (also known as Cain McKnight), who died at age 51 in Dallas in March 2026 under suspicious circumstances shortly after being named as a witness in a Diddy-related civil case. Murder investigations have exploded in Dallas regarding the **Burkle-Ehud Barak** connection to Diddy and Weinstein, with multiple suspicious deaths linked to properties and circles associated with this network. I have also submitted evidence to Antigua CID regarding the murder of my trusted attorney **Mark Lieberman** and the murder of **Asot Michael** ("Asset Michael"). As an observer, I am not satisfied that the murder of Asset Michael has been fully investigated regarding the reasons and influences for doing that, if indeed he is the assailant.
14. The network of lawyers involved at the time of Asset Michael's death — including the **Kingsley Napley** emails that were directed at me and Asset Michael — must be investigated and synthesised with the Burkle/NXIVM network of supporting lawyers such as **John Branca**, **Gloria Allred**, **Gary Dordick**, **Tom Girardi**, **Michael Avenatti**, **David Boies**, **Shari Redstone**, **Dani Peretz**, **Daphne Barak**, and others. Many of these same lawyers are either currently under investigation, have been convicted, or are in jail: Tom Girardi has been convicted of fraud and is imprisoned; Michael Avenatti has been convicted on multiple counts and is serving a prison sentence; the others remain under scrutiny or have faced formal complaints and disbarment proceedings tied to the same pattern of conduct. This overlap between the Kingsley Napley communications at the time of the murder and the broader Burkle/NXIVM-aligned legal network is critical evidence that must be examined by the Royal Police Force. The law firms' activities in Antigua — including Glazer Weil, Howard Kennedy, Kingsley Napley, and the local actions of the above-named lawyers — directly relate to both my family's exploitation and my personal exploitation, with evidence of wrongdoing fully on the record.
15. In **Eastern Caribbean Supreme Court Claim No. ANUHCV2025/0149** (Alkiviades David v. David Boies & Others), where I am the self-represented claimant, the defendants — including the above-named lawyers and firms — have been properly served, remain in default, and face imminent or issued bench warrants (including against the Gary Dordick firm). The facts on the record clearly establish default and entitle me to judgment. Justice Rene Williams was required to rule on these defaults by **12 December 2025** but has failed to do so. This unlawful delay has now stretched for months and remains ongoing, even though the judges and courts cannot change the facts that are already on the record. I am legally in the right lane, and this delay constitutes further court tampering and obstruction of justice that protects the network. The evidence of wrongdoing by all of the lawyers — the London lawyers, the California lawyers, Glazer

Weil, Howard Kennedy, and including Sir Steadroy Benjamin — is fully on the record, together with my request on the record for a further response from the court. That is precisely where the matter has stuck ever since I broke the news and the Alpha Nero lawsuit came in our support, confirming the defamation. The system has since gone even more silent than the **70-plus defaults** now sitting on the Antigua court. This presents an immediate opportunity for the Royal Police Force to bring these defaulting parties into custody pursuant to the bench warrant requests in the Eastern Caribbean Supreme Court and to question them directly on the various murders linked to this cartel, including the suspicious death of **Aaron Cain McKnight** in Dallas, the murder of **Asot Michael** (“Asset Michael”), the murder of my attorney **Mark Lieberman**, and the broader pattern of victim deaths connected to the Burkle-Ehud Barak-Diddy-Weinstein circle.

16. The **Attorney General of Antigua & Barbuda, Sir Steadroy Benjamin**, is alleged to have personally fixed and tampered with my legal paperwork and filings in these and related AG court matters before **Justice Rene Williams**. The AG is linked through his son (an intellectual property lawyer) to the same Diddy/Universal Music Group legal network and the broader syndicate of attorneys. His actions have been directly contrary to the leadership and support provided by Prime Minister Gaston Browne.
17. Senior bank executives (including Jamie Dimon of JPMorgan Chase, Jane Fraser of Citigroup, Brian Moynihan of Bank of America, and others) also remain in contempt/default in related enforcement proceedings.
18. The collective default and silence of these parties constitute an admission by conduct under Antiguan and Commonwealth law. They have no defence to the facts of systemic criminal conspiracy, fraud, tortious interference, CSAM distribution, IP theft, IPO sabotage, related murders, court tampering, defamation (including the Alpha Nero matter and the illusion created using TMZ and Gloria Allred), harassment and financial exploitation of a disabled person in Antigua, weaponization of my TBI disability, unlawful judicial delay, the extortion racket operated through figures such as Corey Feldman, and the betrayal that began with the London family trust and the pedophile network within Leventis-funded businesses.
19. I make this statement from my direct personal knowledge as a disabled person who has endured these coordinated attacks — including the deliberate weaponization and attempted medication of my severe Traumatic Brain Injury, the harassment and financial exploitation I suffered while in Antigua, the Carrington emails and victim files supplied to me, the abuse suffered by my cousin Nicola Leventis, the false accusations against the Leventis twins Evagoras and his brother in Greece, the text messages from the girls used in the illusion, and the ongoing months-long judicial delay in ruling on clear defaults — based on my family ties, business dealings, acting/producing credits, FilmOn work, the Southern District of New York Alpha Nero win and appellate record (uploaded as evidence), the full support of Prime Minister Gaston Browne, the 1990s introductions, and evidence already submitted to law enforcement (FBI, Dallas PD, Antigua CID). I am ready and willing to produce all supporting records, emails (including those from Daphne Barak and Rovier Carrington), trust documents, hologram/IP exhibits, IPO filings, acting/producing contracts, FilmOn acquisition documents, the SDNY order, victim

statements, and affidavits (including the Revolut payment record of £8,000 to Daphne Barak).
