Dear Dr. **Wexler**, I am writing this letter to you and copying interested parties who must also be made aware of the attached information. CBS, CNET Sued for Distributing LimeWire, Other P2P Software

San Francisco - In the same week that file-sharing service LimeWire was in court defending against a potential \$1.4 billion in copyright infringement damages, a number of companies, including CBS-owned ([NYSE: CBS](#)) CNET Download.com, have been sued for distributing LimeWire and similar applications.

The lawsuit was filed by billionaire Alki David, the founder of FilmON, and the plaintiff list includes hip-hop acts such as 2 Live Crew, Ying Yang Twins and The Force MDs.

In addition to CBS Interactive and CNET Networks, the suit also names LimeWire itself.

"The CBS Defendants received massive amounts of revenue from P2P providers on a 'pay per download' basis and also from advertising revenues generated by advertisements placed on the download screen for P2P software," the complaint states, alleging the defendants were "well aware that these software applications were used overwhelmingly to infringe when they first partnered with LimeWire and other P2P providers, but ignored it in exchange for a steady stream of income."

For its part, CBS said in a statement that the lawsuit is "riddled with inaccuracies, and we are confident that we will prevail."

Vuze takes \$20M for IPTV

[Vuze](#), an high-definition internet protocol television service based out of Palo Alto, Calif., has picked up \$20 million in a third round of funding.

The company, which was previously known as Azureus, says its downloadable client has been installed 15 million times. However, it did not disclose how many active users it has.

Vuze isn't the only company to receive a large amount of funding for IPTV recently. Two weeks ago, VentureBeat reported that Avail Media had [raised \\$25 million](#) for its own offering.

The Vuze funding was led by [New Enterprise Associates](#), while previous investors [BV Capital](#), [Greycroft Partners](#) and [Redpoint Ventures](#) also participated. Vuze has now raised a total of \$34 million.
