

ANNEX B — CALIFORNIA JUDICIAL MISCONDUCT AND ENTERPRISE TIES

Submitted as Related Proceedings in Support of Annex A (U.S. RICO Complaint)

I. Introduction

This Annex provides evidence of systemic judicial misconduct within the Los Angeles Superior Court, demonstrating that certain California judges are not independent arbiters, but active participants in the racketeering enterprise described in Annex A. The transcript of Mahim Khan v. Hologram USA, Inc. (Case No. BC654017, Dept. 74, Hon. Michelle Williams Court, November 25, 2019) is enclosed as Exhibit B-2. This record, combined with corroborating investigative reporting published on Shockya.com, proves that California courts have been weaponized by the Allred/Girardi syndicate to enforce fraudulent judgments, suppress whistleblowers, and launder legitimacy onto a criminal enterprise.

II. Judge Michelle Williams (Dept. 74, LA Superior Court)

Origins & Girardi/Allred Connection: Michelle Williams's career was fast-tracked to the Superior Court by Tom Girardi, after first approaching Gloria Allred in a personal domestic violence matter involving her husband. Instead of offering genuine legal aid, Allred and Girardi co-opted Williams into their network, binding her career to their enterprise.

Abuse of Process: The Mahim Khan v. David transcript shows Judge Williams manipulating jury instructions and verdict forms in chambers in ways that advantaged the plaintiff, represented by Allred's firm. Prejudicial exhibits such as '2 Girls 1 Cup' and 'Lord of the Freaks' were admitted into evidence despite irrelevance, designed only to inflame the jury. Closing arguments permitted repeated statements outside the record, with objections overruled. Williams is not a neutral judge, but a judicial instrument of Girardi and Allred.

III. Judge Thomas Falls (Pomona District Court, LA County)

Falls wrongfully incarcerated Plaintiff for six nights on a contempt sentence exceeding lawful limits. He violated ADA protections by targeting Plaintiff's service animal, Vader, and attempted to impose fraudulent psychiatric holds. Falls is accused of racketeering, ADA retaliation, and conspiracy to pervert justice, acting in lockstep with enterprise attorneys.

IV. Judge Yolanda Orozco (LA Superior Court)

Yolanda Orozco's advancement and network are linked to Tom Girardi, already exposed as a central figure in the California Bar corruption scandal. Orozco is also connected to former LA County Sheriff Lee Baca, who was convicted of federal corruption charges and served three years in prison. These associations demonstrate deep entanglement with criminal power structures. Like Judges Williams and Falls, Orozco has participated in issuing or enabling orders that shield the enterprise while obstructing whistleblower claims.

V. The California Judiciary as a RICO Actor

Together, Judges Williams, Falls, and Orozco comprise the California judiciary's operational flank of the racketeering enterprise. They launder legitimacy onto fraudulent filings, enable extortion, and provide judicial cover to a syndicate spanning law, media, and finance. Their ties to Girardi, Allred, and convicted Sheriff Baca demonstrate that California's judiciary is compromised.

VI. Public Corroboration (Shockya.com)

The above allegations are supported not only by filings and transcripts, but also by investigative reporting. See: Shockya.com, 'Babylon is Burning: David v. VII. Conclusion

The evidence shows that California's judiciary is compromised, with sitting judges operating under the control of the Allred/Girardi syndicate. This is directly relevant to the proceedings before this Honourable Court. The UK High Court (KB Division) and the Antigua High Court (Williams J.) are respectfully asked to take judicial notice of Annex B and its enclosed transcript, recognize that the Los Angeles Superior Court is implicated in racketeering, and treat California judicial rulings with skepticism as potential acts of enterprise abuse rather than legitimate adjudications.
