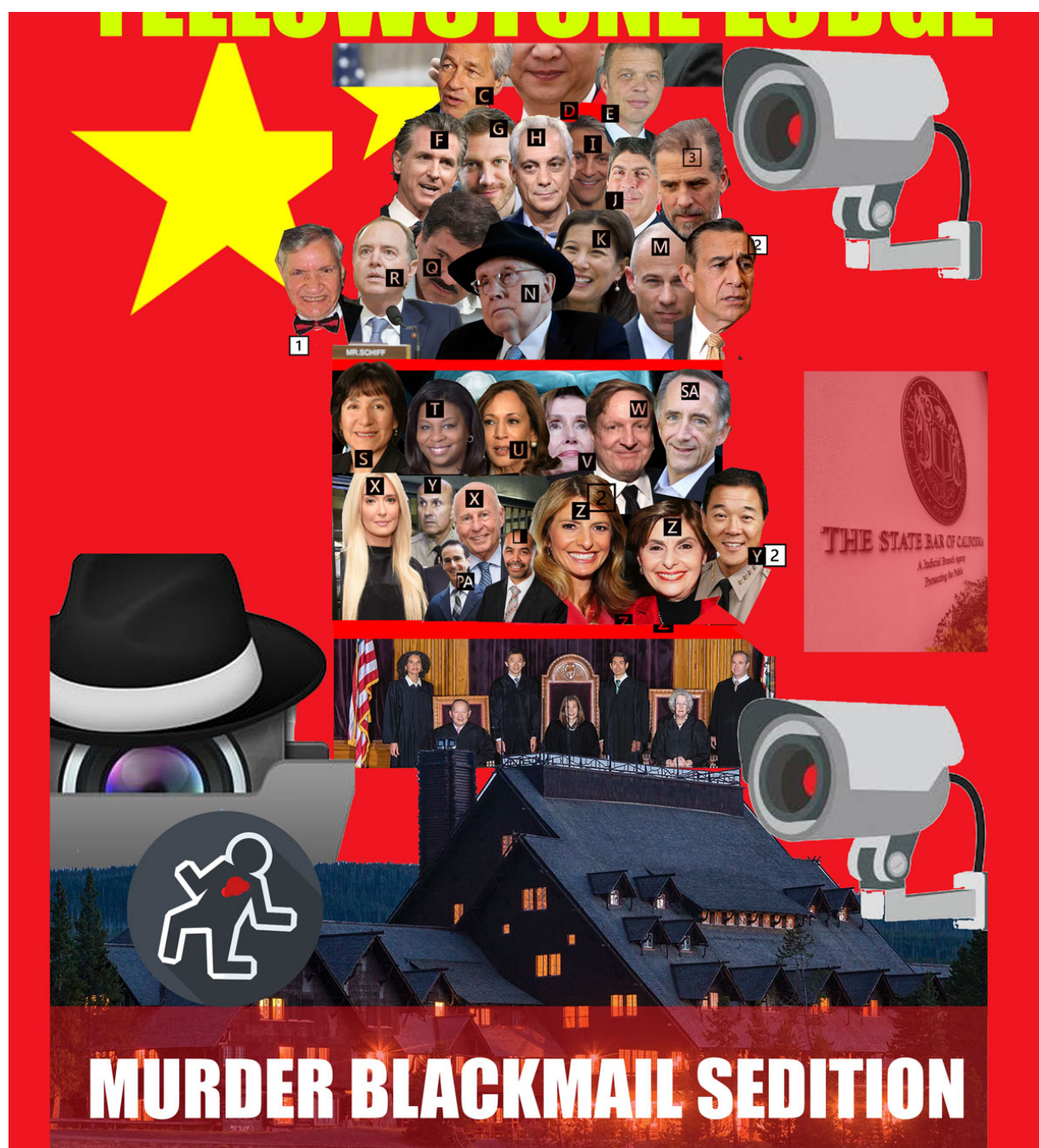

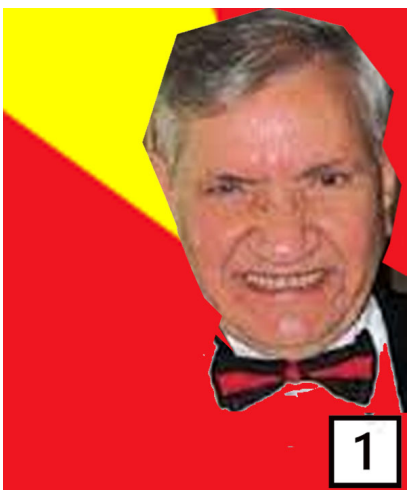
**OPEN LETTER REGARDING THE STATE BAR'S THOMAS V. GIRARDI DISCLOSURE**

Today, the State Bar of California is releasing information about disciplinary matters that were opened and closed over the past 40 years involving now-disbarred attorney Thomas V. Girardi. The handling of the Girardi matters brought to light serious failures in the State Bar's attorney discipline system, failures that have contributed to a lack of confidence in the State Bar's ability to carry out our core responsibility of protecting the public. There is no excuse being offered here; Girardi caused irreparable harm to hundreds of his clients, and the State Bar could have done more to protect the public. We can never allow something like this to happen again.

- Why is Chinese Military at the Mexican border in full fentanyl and amphetamine production? The competition is heating up between rival Sinaloa Gangs and the Mexican Government. This collaboration is based on ancient tradition. China and Mexico have been trading intensively since the 16th-17th century.

Deutsche Bank provides Hollywood production capital and distribution financing for Comcast Ventures productions to feed its colossal global network of media mind share with NBC Universal Properties including broadcast publishing live events, theme parks and security. Worryingly Allied Universal for example is a massive global security company whose reach extends to State Bar Offices and other public/state operations.

It must be noted that Deutsche Bank Germany (the parent) did not acquire Deutsche Bank China till 2018.



### F. GOVERNOR GAVIN NEWSOM

Gavin Newsom is at the heart of the California State Bar scam run by Girardi, Allred, Bloom, Avanatti, and others.

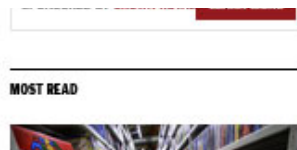

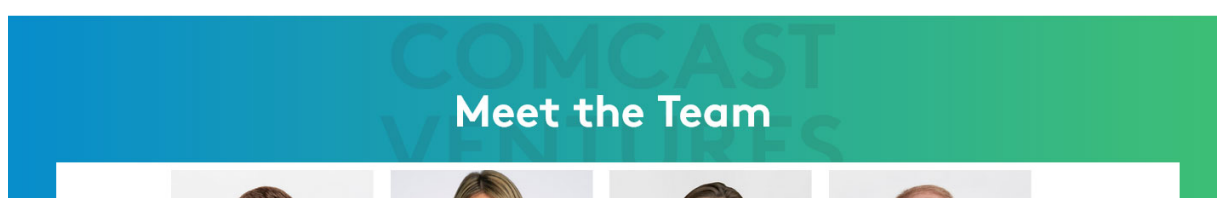


## G. ANDREW CLELAND / MANAGING DIRECTOR COMCAST VENTURES UNIVERSAL

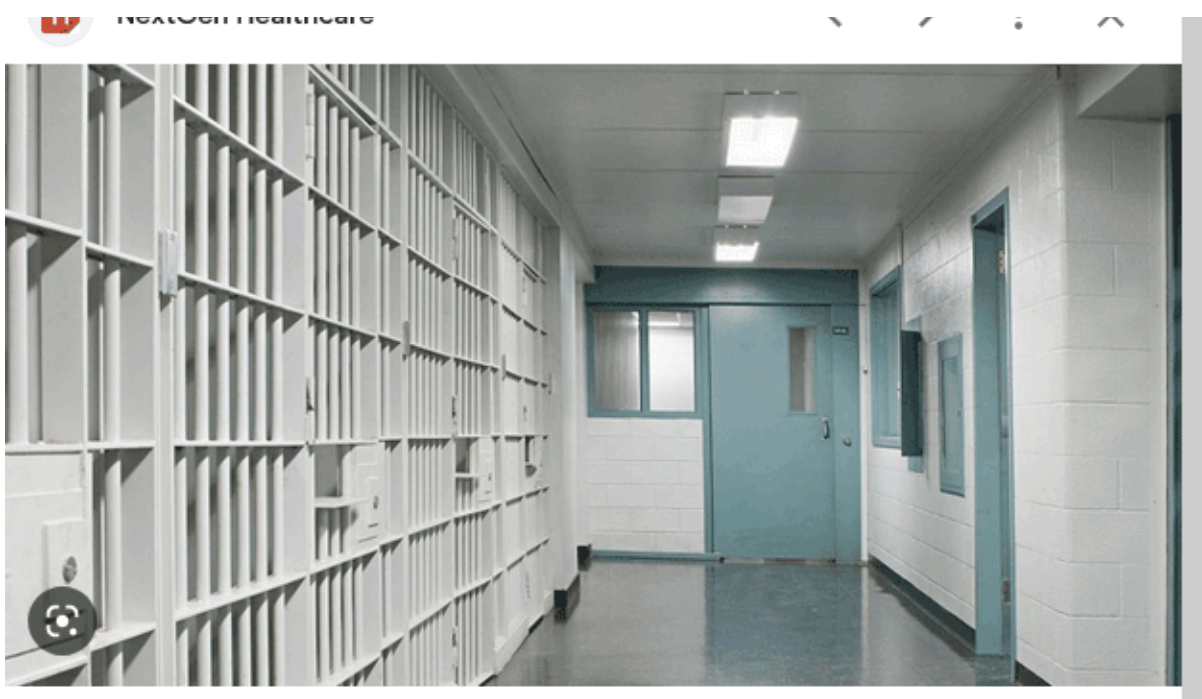

It must be noted that FOX NEWS Network is a China State Owned News Channel. Additionally it must be noted that Comcast Ventures also owns and operates many ratings and approvals systems engineered to further enslave mindshare.

As part of our investigations a novel way to filter out foreign owned content would be for the FCC to force watermarking all foreign owned Over The Air

broadcasters exist either by satellite and all other electro-magnetic transmissions.
