IN THE HIGH COURT OF JUSTICE KING'S BENCH DIVISION Claim No: KB-2025-001991 AFFIDAVIT OF CARL DAWSON Submitted in support of the Defendant, Mr. Alkiviades David (pro se) I, Carl Dawson, declare and affirm as follows: 1. Identity and Professional Background 1.1. My name is Carl Dawson. I am over the age of eighteen (18), of sound mind, and competent to testify to the matters set forth herein. 1.2. I am a former officer in the United States Navy and have worked for over twenty (20) years in telesales and marketing in the Hollywood entertainment and technology sector. 1.3. From approximately 2013 to 2018, I served as Head of Marketing for FOTV Media Networks, under the leadership of Mr. Alkiviades David. FOTV was a visionary and disruptive platform that sought to redefine media

distribution. Working under Mr. David was one of the most creatively fulfilling periods of my career. 1.4. In 2018, I was terminated along with several other team members, but I have remained in admiration of Mr. David's innovative thinking and moral courage in the face of persistent adversity. 2. Statement Regarding Mahim Kahn and the Appeals Proceedings 2.1. I understand that my prior statement supporting Mr. David may have been excluded from the current appellate record in the matter of Mahim Kahn v. Alkiviades David. 2.2. I previously submitted a full statement via attorney Fred Heather of Glaser Weil, which included my observations regarding false allegations made against Mr. David, not only by Ms. Kahn but also by Ms. Marguerita Nichols, the plaintiff in the related \$900 million judgment. 3. Testimony Regarding Marguerita Nichols 3.1. During my tenure at FOTV, I had direct and personal conversations with Ms. Marguerita Nichols, who confided in me on multiple occasions that she had been set up by lawyers to falsely accuse Mr. David of acts he did not commit. 3.2. Ms. Nichols told me, repeatedly, that she regretted taking part in the legal action and that the pressure she was under came from legal professionals who were more interested in financial gain than the truth. 3.3. Based on my observations and interactions, it is my strong belief that Ms. Nichols suffers from mental health challenges and is being coerced or kept captive by those same attorneys or their agents. 3.4. Her allegations, in my personal and professional opinion, are fabricated and sustained by manipulation. I know this because she told me so herself. 4. Final Statement and Declaration 4.1. I respectfully request that this affidavit be accepted as part of the court's record in support of Mr. David, and that the court give full consideration to the disturbing pattern of witness coercion and legal malpractice that appears to underlie this and related cases. 4.2. I am prepared to testify in person or via secure remote link to any court of law, including the High Court of Justice in London.
