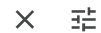

I, **Alkiviades A. David**, make this formal criminal complaint and request that it be recorded, assigned an incident or report number, and i

I am a **cognitively disabled litigant in person** and claimant in related cross-jurisdictional proceedings presently before three courts. I s: of public institutions, and the due administration of justice.

I further record that I had felt safe in Antigua until the conduct of the Attorney General and the police officer during the incident complaine

This complaint is based on matters personally witnessed by me, documentary material already filed with or sent to the Court and Registry, during the incident at the Attorney General's Chambers.

### 1. Complaint concerning suspected interference with the due administration of justic

I have raised with the Eastern Caribbean Supreme Court and the Registry a serious issue concerning documents relating to **UPP party r** the court record.

When clarification was sought from the Registry, I was referred to the Attorney General's Chambers, and the Attorney General's Chambe made the changes, on what authority, when, why, or under what lawful basis.

I further state that I have already filed **default-related notices and materials** with the Court, and that those filings are being obstructed i allowing the default process to proceed in the ordinary course, the matter has been diverted into confusion, delay, and institutional buck-

Because these matters concern court filings, party identity, and the integrity of an active case record, I request investigation of **suspecte** intimidation, or other improper handling of court-related material. Search results from Antigua and Barbuda's laws database show crimin also provisions addressing threatening or intimidating a person.

### 2. Related California appellate proceedings and connected court evidence

I further place on record that related proceedings remain active in the **California Court of Appeal**, and that the respondent side has bee notice when a brief is not filed on time, after which the court may proceed accordingly.
