I represent Rory Tingle, as the Head of Compliance for the Daily Mail, a UK-based newspaper and website ([dailymail.co.uk](https://www.dailymail.co.uk)).

The above URL, which I understand that your company hosts, includes a wealth of highly defamatory and false claims that our journalist, and the organisation I represent, have "hid[de] and abett[ed] a global child sexual abuse material network".

Our reporter, who has no links to Mr David (he has not written about him), simply happened to be entering his place of work when he was physically accosted by Mr David, who has accepted a police caution for this.

As well as false and defamatory content (at the most severe level of reputational harm, linking our employee to child sex abuse), the article also unlawfully uses content owned by Associated Newspapers (owners of the [dailymail.co.uk](https://www.dailymail.co.uk) website) in the form of copyrighted (images taken by our staff photographer and originally published here: <https://www.dailymail.co.uk/femail/article-4962737/MsOnline-recreates-Harry-Styles-Vogue-shoot-London.html>).

1. PURPOSE OF THIS ALERT

This is a formal request for review and coordination with the Dallas Police Department Homicide Unit regarding:

- The death of attorney Mark J. Lieberman;
- The death of Aaron "Cain" McKnight in Dallas;
- Potential overlap with witness activity, litigation exposure, and evidence integrity concerns across multiple jurisdictions.

This alert is submitted on the basis of **reasonable grounds requiring investigative verification**, not as a determination of causation.
