My Lord,

I write with utmost respect to draw the Court’s attention to the status of Mr. Rovier Carrington, whose testimony and evidence have been entered in these proceedings.

Mr. Carrington is not a vexatious litigant nor a fabricator, as hostile press and legal adversaries have sought to portray him. Instead, he is a documented victim of systemic abuse, exploitation, and suppression at the hands of powerful media and legal actors — the very same parties named in the present action.

### **Exploitation in the Media**

Mr. Carrington’s attempts to speak publicly were immediately met with smear campaigns and hostile reporting, orchestrated by the defendants’ networks. Instead of his allegations being fairly weighed, he was branded as dishonest and unstable. These narratives were deliberately propagated to discredit him and shield the perpetrators.

### **Silenced Under Threat of Life**

Evidence now before this Court demonstrates that Mr. Carrington was:

- Threatened with imprisonment unless he signed statements recanting his own abuse.
- Coerced into false admissions under the threat of ongoing prosecution and psychiatric confinement.
- Subjected to intimidation by defense counsel, who ensured that his testimony could not freely be heard in U.S. courts.

His video statements (Exhibits C1 and C2) speak directly to this pattern: a young man compelled to renounce truth to preserve his life and liberty.

### **Victim Status**

It is critical that this Court recognize Carrington as a victim whose voice was silenced by systemic coercion, not as an unreliable witness. The record in Antigua allows his testimony to be considered free from the distortions imposed upon him in prior jurisdictions.

**Conclusion**

On behalf of the Claimant, I respectfully urge this Honourable Court to weigh Carrington's evidence as that of a bona fide victim who was subjected to abuse, silencing, and reputational destruction as part of the broader cartel conspiracy. His voice, once muted, is now restored in these proceedings, and justice requires that it be given due weight.
