## OPENING STATEMENT

### PART I: HISTORICAL ORIGINS TO THE FCC NPRM

The network documented in this case is not an ad hoc coalition of bad actors; it is the present-day iteration of a lineage that began with Meyer Lansky's National Crime Syndicate. This criminal alliance pioneered the integration of organised crime into legitimate-appearing industries — first unions, then gaming, then mass media.

Through the 20th century, Lansky's infrastructure merged with corporate and political interests, embedding in Nevada gaming law via Harry Reid, New York's financial corridors, and the Hollywood entertainment pipeline. These alliances created the foundation for a self-protecting syndicate — one that could launder profits, suppress exposure, and retain influence regardless of political shifts.

Today, this syndicate's control points are concentrated among a handful of interlinked media families and financial actors:

- Shari Redstone – inheritor of the CBS/Viacom empire built by Sumner Redstone, with Nevada political/judicial ties to Harry Reid.
- Rupert Murdoch – FOX empire owner; engaged in narrative alignment with Redstone interests to suppress adverse coverage.
- Bronfman family – Seagram's fortune leveraged into political and media control; implicated in NXIVM trafficking case (convictions of Clare and Sara Bronfman).
- Leslie Wexner – Victoria's Secret founder and principal backer of Jeffrey Epstein; linked to blackmail operations and intelligence-adjacent trafficking systems.
- Maxwell family – Publishing and intelligence-linked empire, via Robert Maxwell and Ghislaine Maxwell, intertwined with Wexner/Epstein operations.
- David Boies – Legal tactician for Weinstein, Wexner, and Epstein-linked matters; repeatedly engaged in suppression campaigns.
- Cascio family – Deeply embedded in Hollywood's music industry; long-time associates of Anthony Pellicano; linked to manipulation of Michael Jackson's posthumous catalogue.

## **PART II: MEDIA RETALIATION, PORNOGRAPHY PIPELINE, CSAM, AND WITNESS ELIMINATION**

Following the FCC NPRM recognition of FilmOn and CinemaNow as lawful MVPDs — the only independents among major conglomerates — the syndicate executed a targeted campaign to destroy my reputation, disrupt my business operations, and eliminate key allies.

CBSyousuck.com, published with supporting evidence (Exhibits F1–F4), documented CBS/Paramount’s direct connections to Child Sexual Abuse Material (CSAM) and trafficking networks. This included:

- Audit logs from MediaDefender showing persistent CSAM circulation on CBS-linked distribution systems.
- Metadata confirming that known CSAM files were monetised rather than removed.

The response was immediate:

- Syndicated outlets under CBS’s influence seeded defamatory pieces — including fabrications such as the “rape room” — into the global news cycle.
- Hostile litigation was initiated within days.
- My business partners received threats of contract termination.
- Search visibility for my name and platforms was algorithmically suppressed.

The speed of retaliation demonstrated that the same infrastructure could be used to identify, track, and shut down trafficking in real time — but is instead used to protect abusers and punish whistleblowers.

### **Hulu / Vivid / Disney / Comcast Pornography Pipeline**

Evidence (Exhibits H1–H5) shows corporate ownership and revenue-sharing between:

- Hulu (Disney-owned),
- Vivid Entertainment (producer/distributor of pornography, including the Kardashian sex tape), and
- Comcast Cable (distribution).

This network monetised explicit celebrity content while maintaining a public “family-friendly” brand. Infrastructure analysis confirms interoperability with CSAM distribution nodes identified in MediaDefender audits.

### **Witness Elimination Pattern**

The cartel systematically removed witnesses with direct knowledge of its operations:

- Rebecca Rini – Co-counsel on FCC NPRM; died under suspicious circumstances shortly after regulatory win.
- Barry K. Rothman – Attorney linked to the Jordan Chandler / Michael Jackson case; later supported my defence. Received 27 pages of Mary Rizzo deposition texts via Dana Cole; these remained buried in Fred Heather’s storage for two years. Rothman died before evidence could surface.
- Mark Lieberman – Died under suspicious circumstances after threats from Joseph Chora.
- John Quirk – Investigator-lawyer; killed after exposing Gloria Allred and Tom Girardi’s financial records.

Each death removed critical testimony and exhibits from the record, benefiting the cartel.

## **WITNESS ELIMINATION TIMELINE**

The pattern of witness deaths is neither coincidental nor isolated. It is an operational method of the cartel to remove those capable of providing testimony or evidence.

- **Rebecca Rini** – Co-counsel on FCC NPRM filings; died under suspicious circumstances within months of regulatory win (Exhibit R1). Her knowledge connected the FCC recognition directly to subsequent suppression efforts.
- **Barry K. Rothman** – Held critical evidence tying Gloria Allred, David Boies, and others to coordinated suppression; received 27 pages of Mary Rizzo deposition texts via Dana Cole, which were buried in Fred Heather’s storage for two years; died before the evidence surfaced (Exhibit R2).
- **Mark Lieberman** – Received threats from Joseph Chora; died under suspicious circumstances; had been investigating CBS/Paramount CSAM links (Exhibit R3).
- **John Quirk** – Investigator-lawyer; killed after exposing Allred/Girardi finances, which directly implicated cartel actors in financial crimes and judicial corruption (Exhibit R4).

Each death occurred during periods of heightened litigation or regulatory exposure, across multiple jurisdictions, and directly obstructed the course of justice.

### **PART III: GLOBAL CONTEXT AND JUDICIAL IMPERATIVE**

The trafficking and exploitation pattern documented in this case exists within a global crisis of unprecedented scale:

- 8 million children trafficked or unaccounted for every year worldwide.
- United Kingdom: Approximately 112,853 children reported missing annually — nearly 1 in every 60 children. Total missing persons cases reach 180,000 annually, most involving minors.
- Jamaica (proxy for the Caribbean): Between 2010 and 2020, approximately 15,000 children reported missing — hundreds per year in a single island nation.
- Small Island Developing States (SIDS), including Antigua & Barbuda: No consolidated missing children data exists, creating a dangerous blindspot traffickers exploit.

This absence of systemic data collection in SIDS mirrors the media–legal–corporate cartel’s control pattern: suppress visibility, disrupt independent oversight, and operate in gaps between jurisdictions.

The record before these Courts is substantial, but it represents only a fraction of the evidence available. In addition to the exhibits cited here, there are dozens of sworn affidavits from lawyers, victims, and insiders that corroborate the existence and operations of the cartel. Many of these statements remain under protective handling due to credible threats against the witnesses.

Patterns evidenced here — monopoly media control, targeted litigation abuse, coordinated suppression of regulatory wins, CSAM distribution, trafficking protection, witness elimination, and exploitation of mass trauma — match the operational structure of a transnational organised crime network.

The Court’s role:

- Recognise this cartel as an organised criminal enterprise operating transnationally.
- Protect whistleblowers, victims, and witnesses from ongoing retaliation.
- Preserve the integrity of the record by ensuring no further suppression of exhibits or affidavits.
- Recommend or initiate law enforcement coordination across UK, Caribbean, and SIDS jurisdictions to address trafficking blindspots.

## LEGAL ARGUMENTS

### 1. Organised Criminal Enterprise – Transnational Scope

The coordinated activities described in Exhibits K1–K3, FCC NPRM filings, Exhibits F1–F4, Exhibits J1–J4, Exhibits H1–H5, and Exhibits R1–R3 establish the existence of a structured group with:

- Ownership tier – Shari Redstone, Rupert Murdoch, Bronfman family, Leslie Wexner, Maxwell family, David Boies.
- Enforcement tier – Howard Kennedy LLP, Fred Heather, Robert Shapiro, Gloria Allred, Rebecca Hume, Ajay Fournillier, Anthony Pellicano, Joseph Chora.
- Distribution tier – Hulu/Disney, Vivid Entertainment, Comcast Cable, CBS Interactive, other platform syndicates.
- Suppression tier – Intimidation, defamation, algorithmic suppression, and the targeted killing of key witnesses.

Statutory hooks: UK Serious Crime Act 2015, Part 1, s.1–2; Antigua Criminal Code Cap. 300, s.20–23; Palermo Convention Arts. 2, 5, 7, 10.

### 2. Criminal Conspiracy to Pervert the Course of Justice

- FCC NPRM suppression: After the regulatory win recognising FilmOn & CinemaNow, co-counsel Rebecca Rini died and hostile litigation commenced.
- Evidence burial: 27 pages of Mary Rizzo deposition texts withheld in Fred Heather's storage for two years.
- Coordinated defamation: Fabricated "rape room" allegation seeded into the global media cycle.
- Witness death pattern: Rini, Rothman, Lieberman, Quirk — all removed before critical testimony could be used.

Statutory hooks: UK common law offence of perverting the course of justice; Antigua Criminal Code Cap. 300, s.20–23.

### **3. Wrongful Death & Intimidation of Witnesses**

- Rebecca Rini – Knowledge of FCC NPRM filings and cartel pushback.
- Barry K. Rothman – Evidence tying Allred, Boies, and others to suppression.
- Mark Lieberman – Threats from Joseph Chora.
- John Quirk – Investigated Allred/Girardi finances.

Statutory hooks: UK Homicide Act 1957; Antigua Criminal Code Cap. 300, ss. 3–5; ECHR Art. 2.

### **4. Trafficking and CSAM-Related Offences**

- MediaDefender audits – Verified CSAM on cartel-linked infrastructure involving children as young as one year old.
- Hulu/Vivid/Disney/Comcast pipeline – Infrastructure overlap with CSAM networks.
- CBSyousuck.com – Exposed trafficking links; met with immediate retaliation.

Statutory hooks: Antigua Trafficking in Persons (Prevention) Act 2010; UK Sexual Offences Act 2003; Palermo Convention Arts. 3, 6; CRC Arts. 19, 34.

### **5. Defamation and Malicious Falsehood**

- Fabricated "rape room" allegation broadcast by cartel outlets.
- Persistent defamatory narratives despite contrary evidence in Exhibits F1–F4 and R1–R3.
- Syndicated repetition across NBC, CBS, FOX, ABC ensured global reach.

Statutory hooks: UK Defamation Act 2013; Antigua Defamation Act, Cap. 104; ECHR Art. 8.

## **RELIEF SOUGHT**

### **Declaratory Relief**

1. Declare the defendants a transnational organised criminal enterprise under UK Serious Crime Act 2015, Part 1, s.1–2; Antigua Criminal Code Cap. 300, s.20–23; and Palermo Convention Arts. 2, 5.
2. Declare the suppression of FCC NPRM recognition, witness intimidation, and concealment of CSAM unlawful and contrary to international obligations under CRC Arts. 19, 34, and ECHR Arts. 2, 3.

### **Injunctive Relief**

1. Restrain all defendants from disseminating false statements, harassment, or evidence destruction.
2. Compel preservation and disclosure of all records related to Exhibits K1–K3, F1–F4, J1–J4, H1–H5, R1–R3.

### **Protective Measures**

- Witness protection orders for surviving whistleblowers.
- Law enforcement coordination across UK, Antigua & Barbuda, and SIDS jurisdictions.

### **Damages**

- General damages for reputational harm, lost business, and distress.
- Special damages for destruction of FilmOn and CinemaNow enterprise value, and unlawful seizure of hologram technology.
- Aggravated/exemplary damages reflecting malice and public harm.

### **Restitution**

- Disgorgement of profits from pornography pipeline, CSAM-linked networks, and trauma bonding content.
- Allocation of a portion to child protection programs under court supervision.

### **Structural Remedies & Oversight**

- Appointment of a special master to audit compliance.
- Revocation or suspension of broadcast/distribution licences until compliance proven.
- Joint UK–Antigua task force to close SIDS data gaps.

---

## CLOSING ARGUMENT

These Courts are presented with an unprecedented choice.

The evidence before you — from sworn affidavits, regulatory filings, audit logs, and corroborated investigative journalism — establishes beyond reasonable dispute that the defendants form a transnational organised criminal enterprise.

It is an enterprise that:

- Controls the narrative levers of the global media.
- Commands legal and enforcement arms capable of silencing whistleblowers anywhere.
- Maintains and profits from distribution pipelines that facilitate CSAM, trafficking, and sexual exploitation.
- Exploits mass-trauma events for ratings and revenue.
- Eliminates or neutralises witnesses through defamation, discrediting, or suspicious death.

Eight million children disappear every year. The infrastructure to protect them exists. It is not used. That is deliberate.

The law can protect the powerful, or it can protect the powerless. Today, it must choose.

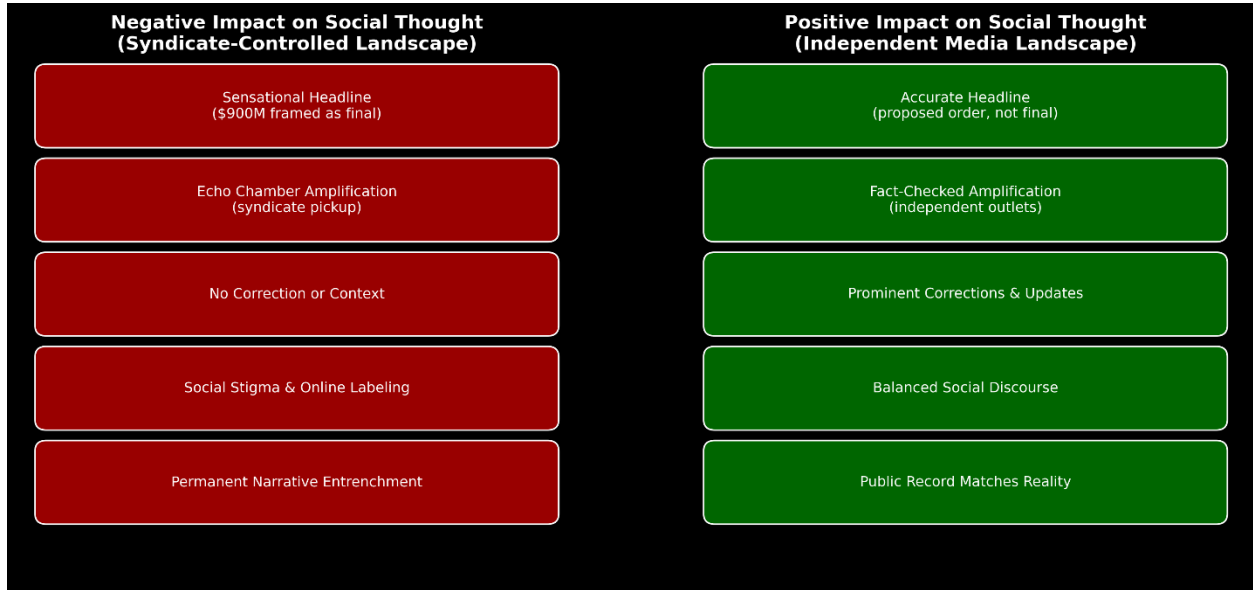

This comparative chart illustrates the contrasting effects on public discourse when the media landscape is controlled by a syndicate versus when it operates independently.

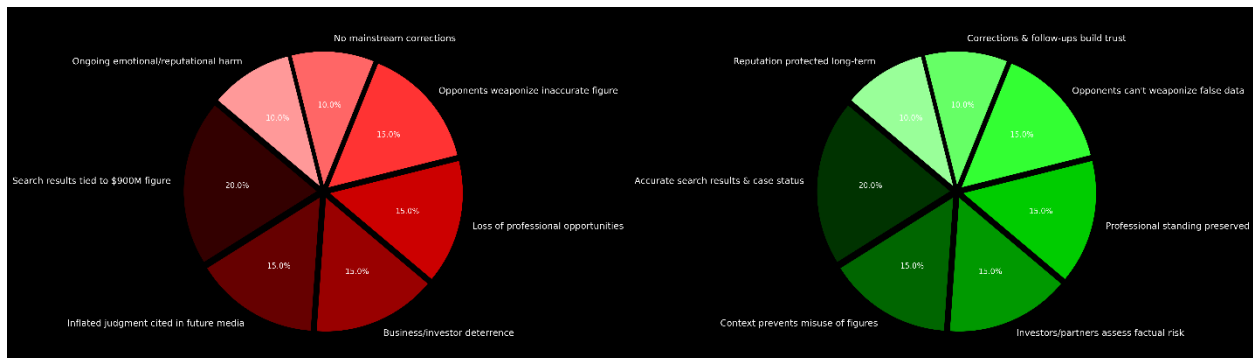


- **Left (Red):** Shows how sensationalism, echo-chamber amplification, lack of correction, and narrative entrenchment create long-term harm.

Side-by-side pie charts quantifying the reputational consequences of syndicate control versus independent reporting.

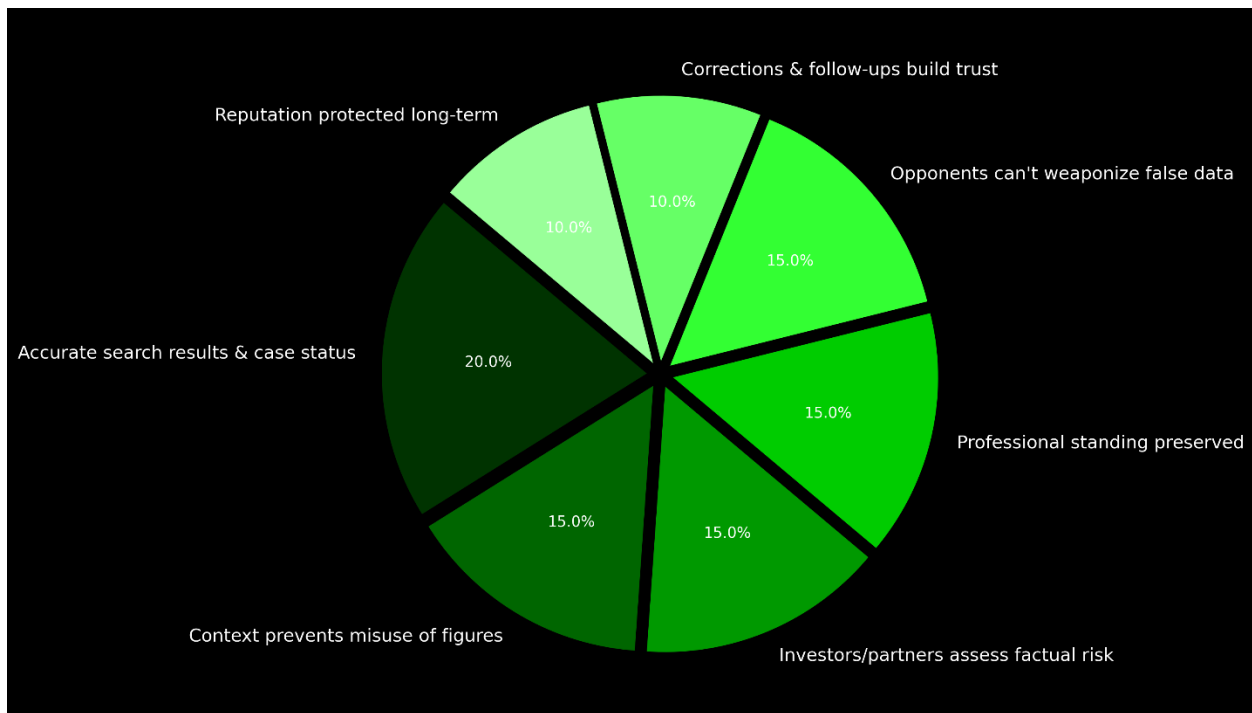


- **Left:** Negative outcomes such as inflated judgments in media, loss of opportunities, and emotional harm.

*Description:*

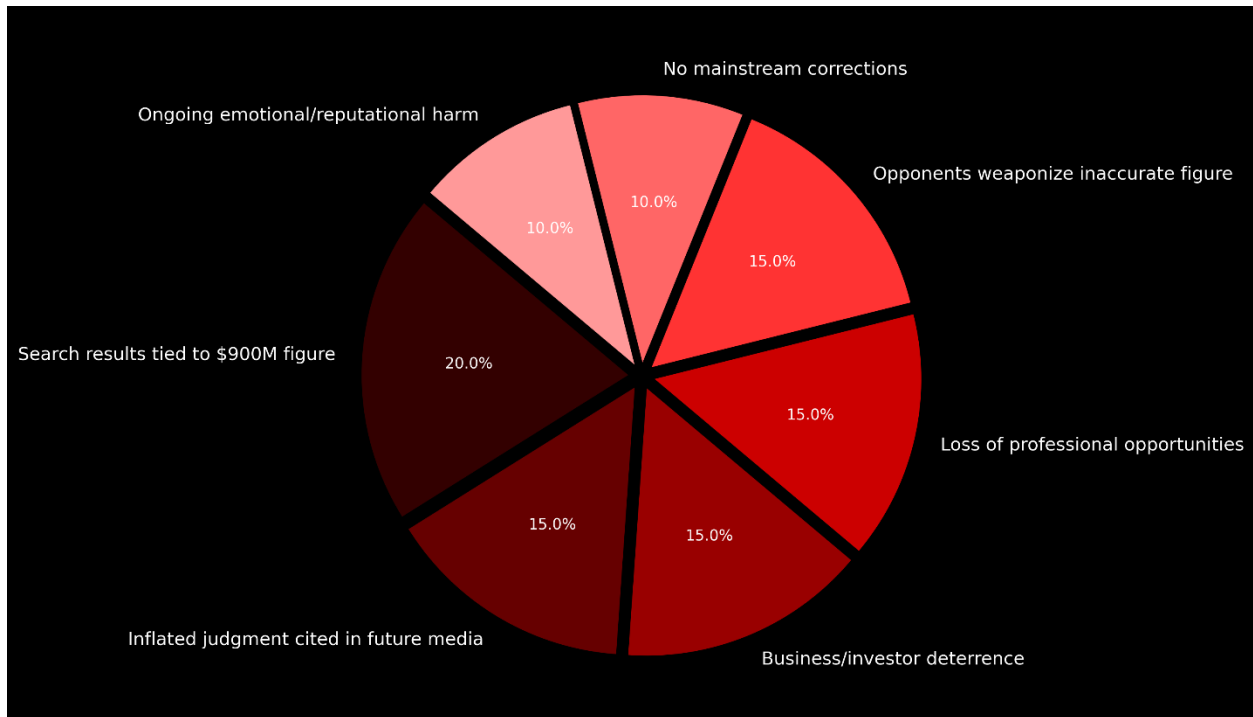
A focused pie chart showing the proportional benefits of independent media coverage, including accurate search results, prevention of false data weaponization, and long-term protection of professional reputation.
