Re: Defamation of Character – For Libel and/or Slander

Dear Mr. David:

We represent Louis J. Freeh. Mr. Freeh is a respected professional in the community and has had a distinguished career in public service. He has spent his life building a positive reputation and has earned as much. We have learned, however, that you have been maliciously spreading inaccurate and unfounded information that is damaging to his personal and professional character and reputation. It is unlawful for an individual to make deliberate statements that intend to harm a person's reputation without factual evidence, and publishing such statements are actionable as libel and/or slander.
