This submission addresses whether enforcement is safe on a materially incomplete evidentiary record.

The Appellant submits that enforcement should not proceed where origin, continuity, and licensing authority remain unresolved.

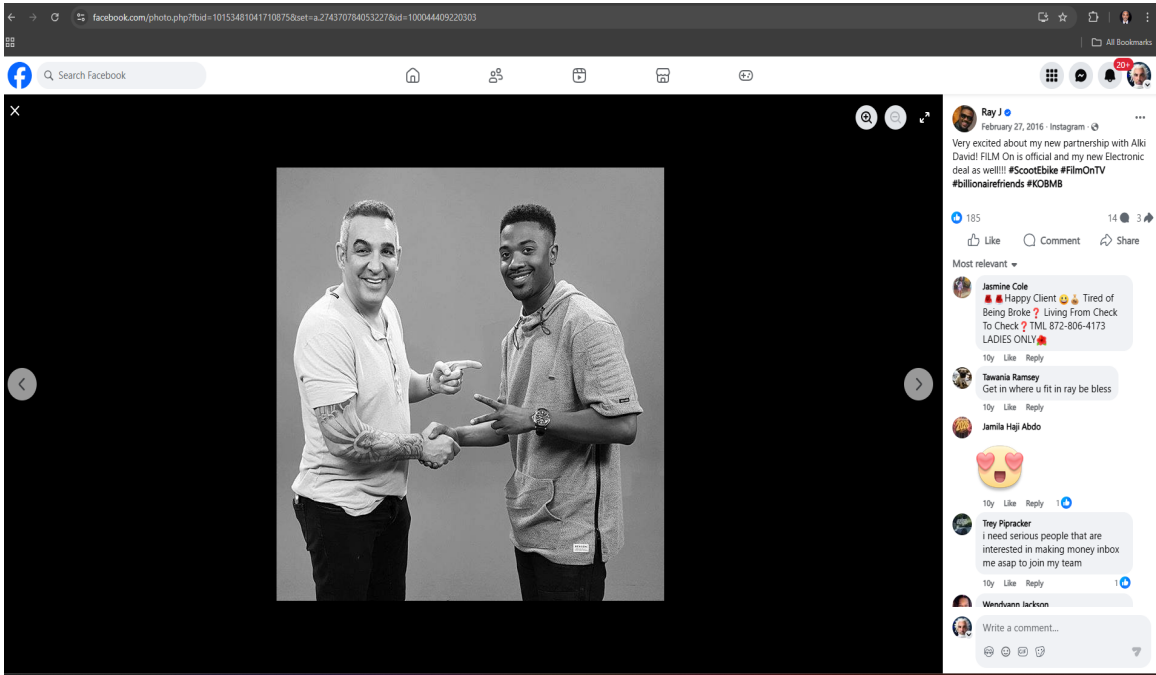
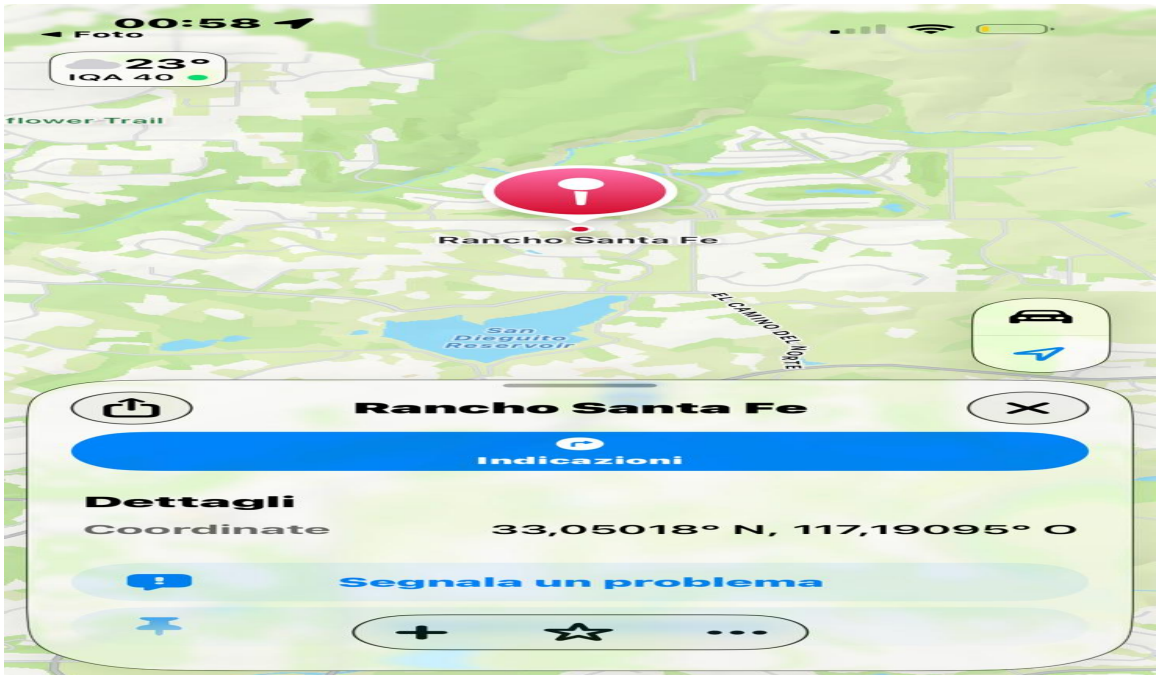
