Hi Alki, Matt, Themis and Alban,

I hope you're well. Thank you for your time in recent weeks and sharing information with me. You raised many issues to me, and I'm still reporting on some of them. It looks like we are proceeding with an initial article on the post-judgment issues as I've discussed with all of you. Some of the plaintiffs are going on the record, and I sought comment from the lawyers.

I'd like to give you a heads up about what I'm planning to reflect so far from the conversations I've had with Alki and some of you. I tried to break them down as individual facts to make them easier to review. If you spot any factual errors, please let me know by Sunday night or at the latest 9am ET Monday. I'd be grateful if you can please double check my numbers, too.

<>Alki's name is spelled Alkiviades "Alki" David.

<>Alki David is 57 years old.

<>Alki David launched several media and technology ventures in Los Angeles, including FilmOn and Alki David Productions.

<>Alki David was born in Nigeria to a wealthy Greek family that holds a major stake in Coca-Cola HBC.

<>Alki David is an heir to a Coca-Cola bottling fortune who was widely believed to be a billionaire.

<>Coca-Cola HBC is a bottling business in 29 countries across Europe and Africa.

<>Alki David has owned luxury homes in California, London, Switzerland and Greece.

<>Alki David left the U.S. even before the final verdicts rolled in.

<>Alki David has denied all the allegations of workplace misconduct.

<>Alki David has dismissed some of the alleged behavior as workplace high jinks.

<>Alki David said he wasn't provided necessary accommodations for his disability during trials.

<>Alki David said he didn't get to introduce text messages that he believes would have swayed the juries.

<>Alki David said he wasn't present at the later trials.

<>Alki David's comments on lawyers: "They just want to get as much money off people and split it up amongst themselves," he said of the lawyers, including his own U.S. lawyers.

<>Alki David has accused the lawyers of orchestrating the cases for financial gain.

<>Alki David told me this: "Even if I had all the wealth in the world, I wouldn't give them a penny anyway...Why would I do that?"

<>Alki David has been spending much of his time in London and the Caribbean nation of Antigua and Barbuda.

<>Alki David is fighting debt-collecting lawyers.

<>Alki David shared medical evaluations with the Journal that indicated he has been diagnosed with a traumatic brain injury and paranoia.

<>Alki David said the damage to his brain contributes to impulse control issues and angry outbursts that make him "go full Karen."

<>Alki David cited the brain injury in court and on his Instagram feed where he critiques lawyers and the California court system.

<>Alki David has staged and filmed public encounters with lawyers.

<>In a YouTube video posted in 2022, Alki David confronted Gloria Allred in a parking lot and yelled expletives at her while she loaded up her car.

<>Alki David isn't a U.S. citizen.

<>Alki David said immigration issues have prevented him from re-entering the country in recent years.

<>Alki David said he recently filed a lawsuit in Antigua accusing various lawyers of fraudulent litigation, suppression of exculpatory evidence and psychiatric abuse.

<>Alki David questioned the credibility of The Wall Street Journal and threatened to add the newspaper to the Antigua lawsuit.

<>One of David's properties, a beachfront home in Malibu, Calif., was the subject of an extended standoff between Alki David and Joseph Chora.

<>In 2023, a court-appointed receiver took possession of Alki David's Malibu house, and it was sold last year for less than what was owed on the mortgage.

<>This year, collection lawyers identified a U.S. bank account connected to the home with roughly \$3.7 million.

<>After a mortgage lender on the Malibu home took a portion, Bloom's client Chasity Jones split the remaining amount with Allred's clients.

<>BakerHostetler seized more than \$3 million from the sale of a Swiss chalet that Alki David co-owned.

<>More than \$13 million was set aside from the sale of a property David owned on the Greek island of Spetses.

<>Themis Sofos is a lawyer for Alki David in Greece.

<>Themis Sofos said he is appealing the enforcement of the U.S. judgement in Greece.

<>Themis Sofos said Greece, like many other European countries, doesn't typically recognize or enforce punitive damages awarded by U.S. courts.

<>Alki David has disputed Joseph Chora's characterization of his wealth (Chora gave this testimony at Elizabeth Taylor's trial - I can send a rundown if you don't remember.)

<>Joseph Chora also subsequently said Alki David had millions of dollars and that he pulled most of the equity out of his Malibu house into a U.S. bank account (the one with \$3.7 million) and Alki David transferred assets to a trust in South Dakota that he said was for his children.

<>Alki David said he once paid a journalist to get on a billionaire list.

<>Alki David said: "I used to be a very rich guy, and I got completely destroyed by these people." Alki David was referring to the plaintiffs and their lawyers.

<>Alki David said he wasn't interested in settling with Bloom's clients. He told the Journal he feels so strongly about his innocence that he has vowed not to pay a penny if he can help it.

RE: Legal Notice and Formal Rebuttal to The Wall Street Journal's Misleading and Defamatory Coverage of Alkiviades "Alki" David

This letter constitutes a formal legal objection and demand for correction regarding your recent coverage authored by Khadeeja Safdar, which misrepresents facts, conceals material legal victories, omits key rulings, and frames me through a lens of bias and provable distortion. This communication is submitted with counsel copied, and will be entered into the record of pending proceedings in the UK and Antigua, as well as any future international filings.

I. CBS INTERACTIVE WAS FOUND CULPABLE

Your publication fails to disclose that the case of Alkiviades David v. CBS Interactive resulted in CBS being found culpable in federal court. CBS was found to have engaged in defamatory and unlawful conduct, including IP misappropriation and reputational interference directly targeting my company FilmOn and its related ventures. This legal outcome formed part of a broader pattern of suppression against me by entrenched media entities. Your omission of this ruling is material and legally consequential. It is also part of a pattern of suppression by your publication of any successful litigation outcomes in my favor.

II. ADDITIONAL LEGAL VICTORIES OMITTED

In addition to the above, your article omits the following:

- *FilmOn v. DoubleVerify*: Ruled in my favor by the California Supreme Court. The court rejected DoubleVerify's SLAPP defense and allowed our claims to proceed.
- *Hologram USA v. FOX*: FOX settled after misappropriating my patented holographic display technology. The case was resolved in my favor.
- *Comcast Licensing Payment*: In 2025, Comcast paid \$450,000 in licensing fees, an explicit recognition of my rightful IP ownership. This payment followed years of obstruction and refusal to license.
- *Judicial Rejections in Greece*: Greek courts have declined to enforce punitive U.S. judgments due to violation of due process and fundamental rights under EU and ECHR standards. This fact, confirmed by my Greek counsel, Themis Sofos, is omitted despite your awareness.

Each of these outcomes is publicly documented. Your failure to report them demonstrates not journalistic discretion, but actual malice.

III. PENDING INTERNATIONAL WHISTLEBLOWER ACTIONS

Contrary to the vague framing in your article, I have filed legal action in the Eastern Caribbean Supreme Court, specifically ANUHCV2025/0149, naming attorneys including Gloria Allred, Lisa Bloom, David Boies, and Joseph Chora. The lawsuit alleges fraudulent litigation, suppression of exculpatory evidence, and psychiatric abuse. These actions are supported by forensic and testimonial evidence, and are being advanced with sovereign and intergovernmental oversight. Filings and evidence from this matter will also be submitted to United Nations corruption, whistleblower protection, and human rights channels, under the relevant treaties.

IV. FAILURE TO REPORT ON VICTIMS, WITNESS DEATHS, AND EVIDENCE SUPPRESSION

You have been made aware of multiple victims of child abuse, coercion, and medical abuse linked to the litigants you selectively quote. You were notified of the verified deaths of attorneys Mark Lieberman, Barry K. Rothman, Rebecca Rini, and investigator John Quirk, all of whom played critical roles in the defense of my case and died under suspicious circumstances. Additionally, you were informed of the 27 pages of verified text messages provided under deposition by Mary Rizzo. You omitted all of this, and published only character-based distortions, thus aiding in the continued defamation of myself and suppression of legal truth.

V. MISREPRESENTATION OF IMMIGRATION STATUS AND DISABILITY

You falsely stated or implied that I fled the United States before verdicts were rendered. In truth, I was denied entry into the U.S. after being stopped in Miami over a trace amount of legal CBD oil aboard a private jet with attorneys. CBD is lawful under the 2018 Farm Bill. Your portrayal is false and defamatory.

You further used my medical diagnosis of traumatic brain injury (TBI) to imply instability and diminish credibility, while omitting that I was denied court accommodations as required under the Americans with Disabilities Act (ADA), the UK Equality Act 2010, and the European Convention on Human Rights. This pattern of omission exposes your publication to further liability under disability rights law.

VI. PROPERTY SEIZURE FRAUD AND ENFORCEMENT MISCONDUCT

You failed to investigate or report that the seizure of my Malibu home occurred without proper service. You further failed to report that Joseph Chora's representations were challenged by legal filings and contradicted by sworn testimony in other jurisdictions. Assets were seized through ex parte hearings and improper enforcement, violating basic due process and judicial neutrality.

VII. DEMAND FOR CORRECTION

Pursuant to California Civil Code § 48a, UK Defamation Act 2013, and IPSO editorial standards, I hereby demand:

1. Full retraction of statements implying unlawful conduct, flight from justice, and mental instability.
2. Publication of a correction acknowledging the legal outcomes listed above, including the CBS Interactive ruling, the Supreme Court wins, and Comcast licensing settlement.
3. Publication of a right-to-reply letter including this legal notice or its substantive summary.
4. Preservation of all internal communications, source interviews, drafts, and emails relating to the article in question for pending litigation and discovery.

VIII. FINAL NOTICE

This matter will not be quietly buried. Legal proceedings are already underway in multiple jurisdictions, including civil, criminal, and international tribunals. The Wall Street Journal, and those complicit in this coordinated media assault, are now on record. The omissions in your reporting rise to the level of reckless disregard and intentional misrepresentation under U.S. and UK defamation law. You are hereby placed on notice of potential legal action under both domestic and transnational legal regimes.

I respectfully submit that the sale of my **Malibu residence** was conducted under **coercive and undervalued conditions**, leaving **no funds for Allred and Bloom and Girardi**.

I personally disclosed the full extent of my assets to **Joseph Chora, while I was in court and still believed in the sanctity of the judicial process**. I did so in good faith, trusting that the system would uphold fairness and protect my rights. That trust was catastrophically violated. Chora later exploited that information to **orchestrate the seizure of my computers, DVR systems, and sensitive business materials**.

He acted in direct coordination with **Terry Vance Luce**, a known enforcer, and with the involvement of **corrupt elements of the Los Angeles County Sheriff's Department**, who facilitated my **illegal incarceration for six days**. I was denied due process and access to counsel.

This incident is part of a broader campaign of **judgment racketeering, legal sabotage, and asset targeting** now being examined by sovereign courts and international investigators. From day one, **I have been completely transparent**, acting in full faith with law enforcement, the judiciary, and my legal teams.

- Several pieces that **should have been published or supported**—particularly regarding whistleblowers and judicial fraud—**were deprioritized or stalled** without adequate explanation.
- I am still assessing whether this is due to pressure, passive complicity, or something deeper.

Until proven otherwise, I will exercise **cautious distance** with Sophos and his associates, and I advise my allies to do the same. **Too much is at stake** to allow any weak links or double agents to disrupt our momentum.

This movement is about **truth, exposure, and justice**. We've uncovered a **vast criminal apparatus** stretching from Hollywood to the UK courts, from MediaDefender to the State Bar of California. People like Khadeeja Safdar and possibly Themis Sophos either **stand with**

the truth—or they are instruments of suppression.

We no longer have the luxury of being polite or naïve. We name names. We expose systems. And we fight in the light.
