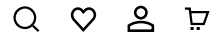

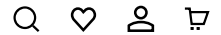
Jay-Z and Beyoncé's lawyers have responded to singer [Jaguar Wright](#)'s bizarre claims by sending Piers Morgan a legal request to cut her defaming comments made on his show, *Piers Morgan Uncensored*.

Wright recently appeared on Morgan's program where she gave her perspective on the headlines surrounding Diddy's recent arrest and the questions and accusations relating to it. "For four years I've been screaming not just Diddy, but Diddy and Jay-Z are monsters," said Wright. 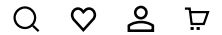

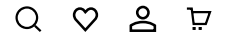

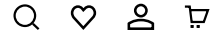
