DEFENDANT'S SUPPLEMENTAL NOTE RE PUBLICLY INDEXED MATERIAL, FREEDOM OF EXPRESSION, AND EXHIBIT IDENTIFICATION BY ORIGINAL FILENAME

1. This short supplemental note is filed for record-assistance only. It is not tendered as a request that the Court accept as proved every allegation contained in third-party articles, search summaries, or result headlines. Its immediate purpose is narrower: (i) to identify the present exhibits by their original filenames, (ii) to show the public indexing and discoverability of material concerning the Defendant and related subjects, and (iii) to place that material against the current procedural posture of this matter.
2. The present procedural anchor is the sealed order dated 24 March 2026, which records that the hearing listed on 7 April 2026 was adjourned to the first available date after 28 April 2026, with costs in the case and service to be effected on the Defendant. The original filename of that exhibit is: "2026.03.24 - KB-2025-001991 - ICO - Adjournment order (REC 31.03.2026).pdf".
3. Two contemporaneous press exhibits are included because they show that the 2010 Philadelphia Obama-rally streaker incident, and the Defendant's association with the publicity offer around it, were matters reported publicly at the time. The original filenames are: "\$1 Million Streaker Prize Up to White House.pdf" and "Probation for Obama rally streaker _ Irish Independent.pdf".
4. The CNBC exhibit reports that a man who ran naked at President Barack Obama's rally in Philadelphia likely won, or probably had won, the USD 1 million prize offered by Alki David, subject to confirmation from the Obama camp. The Irish Independent exhibit reports that Juan Rodriguez later received probation and had been trying to win the million-dollar prize offered by internet billionaire Alki David.
5. Three further exhibits are screenshot captures dated 8 April 2026 showing public Google search results. They are included for the limited purpose of showing public indexing, discoverability, and the fact of public surfacing of related material. They are not submitted as proof of every proposition embedded in the underlying headlines or search summaries. Their original filenames are: "Screenshot 2026-04-08 at 10-08-27 OBAMA BOIES - Google Search.png"; "Screenshot 2026-04-08 at 10-08-44 OBAMA BOIES - Google Search.png"; and "Screenshot 2026-04-08 at 10-09-35 EHUD BARAK HUSSEIN OBAMA - Google Search.png".
6. The first "OBAMA BOIES" screenshot shows a Google News result surfacing a Shockya article under the headline "OBAMA - BARAK - BRANCA - BOIES - Named As Key Operators - Alki David's New Multi-Court Offensive Says London May Be Enforcing a Case Through the Wrong Face -". The second "OBAMA BOIES" screenshot shows a Google results page that includes an AI Overview describing a public relationship between President Obama and attorney David Boies, and also surfaces the same

Shockya result. The "EHUD BARAK HUSSEIN OBAMA" screenshot shows a Google News page surfacing, among other items, a Shockya result and a WION result.

7. Relevance: these exhibits go to public-domain context, freedom of expression, and the practical impossibility of treating the Defendant's publications and surrounding commentary as if they were hidden or non-public. They also show that the Defendant's name, publications, and related subject matter are readily discoverable through ordinary public search tools. That is relevant to issues of publicity, causation, context, and proportionality.

8. The Defendant therefore respectfully asks that this supplemental note and the attached exhibits, identified by their original filenames, be placed on the record and read together with the existing application and appeal materials. The Defendant reserves the right to rely upon the underlying publications themselves, and upon further material already filed or to be filed, for the more complete public-interest and expression context.

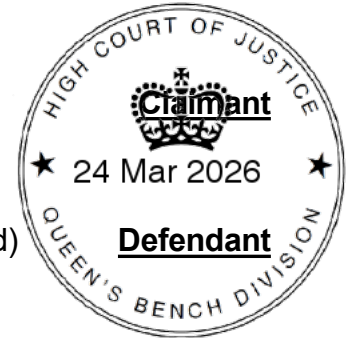

A man who ran naked at President Barack Obama’s rally in Philadelphia in the weekend has likely won \$1 million - but only if someone in the Obama camp confirms the man was close enough to the commander in chief.



“We’re delighted to say (the streaker) probably has (won the prize),” billionaire Alki David told CNBC.

David recently offered \$1 million to anyone who could streak in front of Obama with Battlecam.com, the name of David’s competition Web site, written on his or her chest and shout “Battlecam” six times





exposure, public lewdness and disorderly conduct after he allegedly streaked at the rally. Rodriguez was arraigned Monday night and released on a \$10,000 signature bond.

[The video of Rodriguez apparently streaking is on Youtube.com.](#) (Warning: this clip contains nudity).

“We’re very happy, he has done everything (to win the challenge),” David told CNBC.

[In a previous interview with CNBC](#), David said costs such as lawyers and fines needed to be taken into account, and that he had been contacted by between 150 and 160 “serious” applicants for the prank.

“I have the lawyer on, (Rodriguez is) out on bail and out of jail,” David told CNBC, adding that “the three charges are 2nd-grade misdemeanors.”

Asked why he chose Obama as the target, David had earlier told CNBC that although he is an Obama fan, it’s because of the president’s global reach.

“I have nothing against him, I think he’s an awesome human being, I really do. He just happens to be the wrong president at the wrong time,” David said.

The only thing standing between Rodriguez and the \$1 million prize is confirmation from the Obama camp that the President was within ‘eyesight and earshot’ of the streaker.

David hopes this will be done Tuesday.

“We will be presenting the prize at (Rodriguez’s) home in New York City,” David told CNBC, adding, “We’re looking forward to handing (over) the cash.”

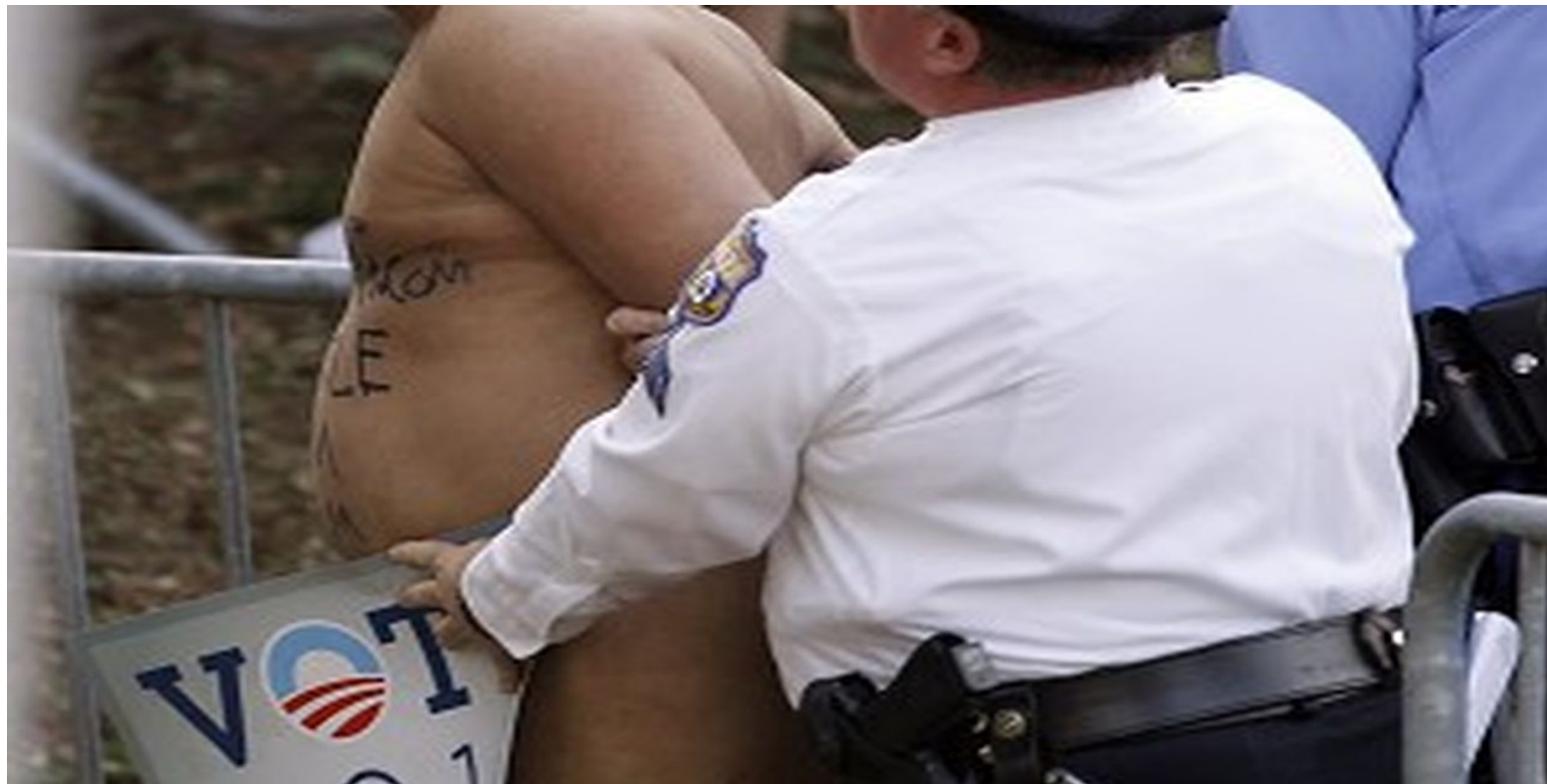

A US man has been sentenced to probation for streaking at a rally for President Barack Obama in Philadelphia.

Twenty-four-year-old Juan Rodriguez of New York City was arrested on charges of indecent exposure, disorderly conduct and open lewdness after streaking at the October rally before thousands in the city's Germantown section.

He was trying to win a million-dollar prize offered by internet billionaire Alki David. Rodriguez did not get the one million US dollars.

The Philadelphia Daily News reports that a judge sentenced Rodriguez to two years' probation to be served in New York.

Rodriguez said he picked Philadelphia because he thought the city would be more lenient. Prosecutors had been seeking three to 23 months in jail.
