And we are fighting it—in **London**, and in the **High Court of Antigua and Barbuda (Claim No: ANUHCV2025/0149)**, where the same syndicate is attempting to collapse the SwissX Sovereign Wealth Fund and shut down sustainable Caribbean innovation.

The government of **Antigua and Barbuda**, under the leadership of **Prime Minister Gaston Browne**, has taken a clear and principled position in support of **sovereignty, transparency, and innovation**. PM Browne has denounced foreign-backed legal interference and affirmed the importance of defending local and international partnerships like SwissX.

Today, that same machinery is attempting to sabotage alliances like the one between Prime Minister Gaston Browne and SwissX founder Alki David, who together are challenging corporate colonialism and restoring sovereign rights. As the Crown strengthens its bonds with Antigua and Barbuda, the syndicate retaliates—desperate to suppress a rising wave of justice that threatens their impunity.

His administration recognizes that the attacks on me are not isolated — they are part of a larger effort to undermine Antigua's legal system, its financial independence, and its role in setting a new global model for regenerative development.



One of the most telling connections: **Howard Kennedy LLP**, the law firm currently representing Mahim Khan, was also involved in the **Julian Assange embassy projection**. That occurred while Howard Kennedy attorneys were actively advising the Assange campaign. Now, that same firm is leading the effort in **Mahim Khan v. Hologram USA** — a direct conflict of interest and a brazen attempt to erase my IP through the backdoor of corrupted litigation.



II. THE CASE OF VIRGINIA GIUFFRE

4. Virginia Giuffre was presented to the public as one of Jeffrey Epstein's most high-profile accusers.
5. Represented by **David Boies**, her case became a symbol of Boies' moral posturing on abuse, even as his firm was under fire for representing predators like Harvey Weinstein.
6. In late 2023, **Giuffre was reported missing**. A week later, reports of her "suicide" emerged.
7. However, investigative journalism by **Shockya.com**, **Lady Victoria Hervey**, and whistleblowers in the Epstein case revealed that **Giuffre had faked her own death** under pressure and was "suicided" shortly after being exposed.

8. **The Alpha Nero Debacle**

What started as a sanctioned yacht seizure by Antigua's Prime Minister **Gaston Browne** turned into a legal disaster for **David Boies**.

He sued a sovereign government—and even **me**, Alki David—in a botched attempt to reclaim a \$100M superyacht tied to Russian oligarch cash.

But the case backfired.

Boies exposed his own network of corruption, asset theft, and political interference.

Alpha Nero wasn't just a yacht.

III. DAVID BOIES' ROLE IN ORGANIZED LEGAL RACKETEERING

David Boies, who also represented **Elizabeth Taylor** and **Marguerita Nichols (Jane Doe in 20STCV37498)** in cases against me, has repeatedly engaged in malicious prosecution and media defamation in tandem with **Gloria Allred** and **Lisa Bloom**.

IV. THE WSJ ARTICLE BY KHADEEJA SAFDAR

In early 2024, I reluctantly cooperated with **Khadeeja Safdar** of the Wall Street Journal, believing she would expose the misconduct of **Allred, Boies, and Mahim Khan**.

Despite presenting irrefutable evidence—including text messages, witness affidavits, sealed depositions, and KPMG/BDO audits—Safdar chose to **bury the evidence**, producing instead a **targeted hit-piece** aimed at destroying my credibility. That article was weaponized in the public and legal arenas to support Mahim Khan's claim, despite its reliance on discredited witnesses and omitted facts.

V. THE MEDIA SYNDICATE AND UK CONNECTION

The tactics used in the U.S. mirror those deployed in the UK.

I have personally witnessed the role of Inside Edition, Daphne Barak, and others, sent by CBS and other groups to intimidate, misrepresent, and defame me.



This Court must be aware that the **Mega Group**, a shadowy cabal of media and legal operatives including **Les Moonves**, **Shari Redstone**, chairwoman of **Paramount Global** and **National Amusements**, is not currently facing formal bribery charges. However, her decision to support a \$16 million settlement with former President Donald Trump—part of a \$20 billion lawsuit over a CBS “60 Minutes” interview—has sparked serious accusations and concerns about potential bribery.

Rupert Murdoch, and **David Boies**, both directly responsible for much of this coordinated campaign.

Their goal has been to suppress **SwissX**, destroy **my credibility**, and enable the theft of my **intellectual property** and **carbon-based sovereign wealth assets** in Antigua and Barbuda.

VI. REQUEST TO THE COURT

I ask this Honourable Court to consider these facts in light of the broader campaign of **Judicial Lawfare**, Media Abuse, and Witness Intimidation.

The **Giuffre case** illustrates the sinister capabilities of this network to **erase witnesses**, fabricate narratives, and weaponize the legal system.

It also exposes the ongoing risk to me and others, and the need for this Court to scrutinize any **foreign enforcement order** brought by claimants with proven links to this cabal.

Who Is Behind the Curtain?

The individuals listed below are not lone actors. They operate under the protection and political cover of what I call the **Predator Elite** — a transnational syndicate of media barons, corrupt attorneys, state-sanctioned intelligence handlers, and corporate fixers. At the center of this structure is **Gloria Allred**, the legal architect who built and managed the network’s strategic litigation warfare apparatus. My co-victims and collaborators have long referred to these actors as **Predators**, not just because of their tactics in courtrooms, but because of their connection to **labor racketeering and the trafficking and cover-up of CSAM (child sexual abuse material)**. Allred and her crew do not act alone — they protect and enforce the interests of the world’s most dangerous corporate criminals. Her operations provide legal justification for character assassination, civil asset forfeiture, and the quiet disposal of dissenters. 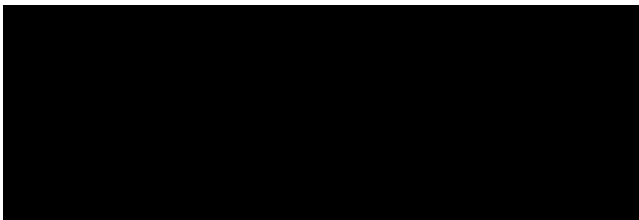

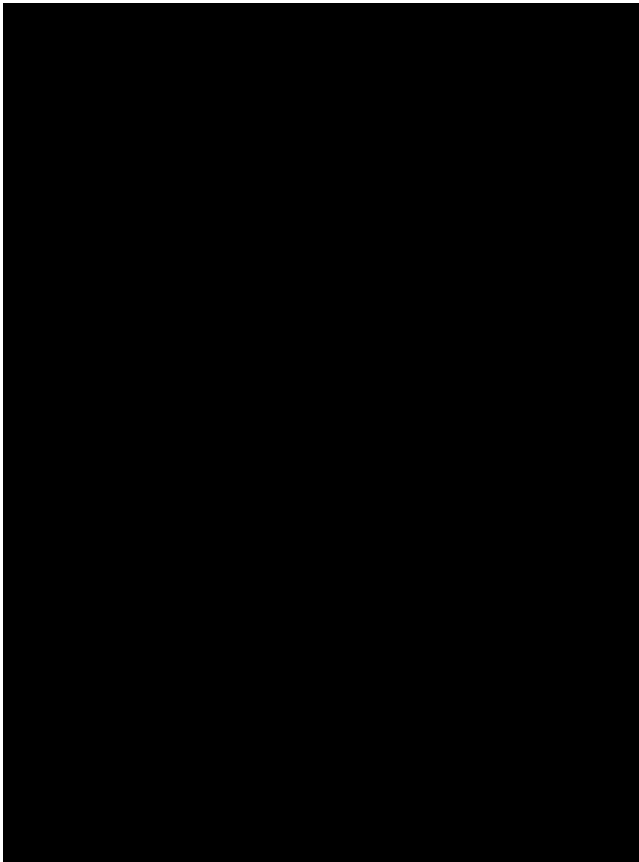

High Court Record: Live Proceedings

During live proceedings before **Sir Barry Paul Cotter** in the UK High Court (King's Bench Division), submissions were made concerning contemporaneous emails sent by **Khadeeja Safdar**, identified in court as a *Wall Street Journal* reporter, while the hearing was underway.

The emails were shown to the court **in real time as they were being transmitted** and were addressed on the record during the hearing itself. Submissions stated that the communications purported to vindicate **Alki David**.

Their **timing, content, and purpose** were raised before the judge as matters of procedural significance, given their emergence during the live hearing rather than through ordinary court channels.

All references in this section relate solely to submissions, materials, and representations made in open court.



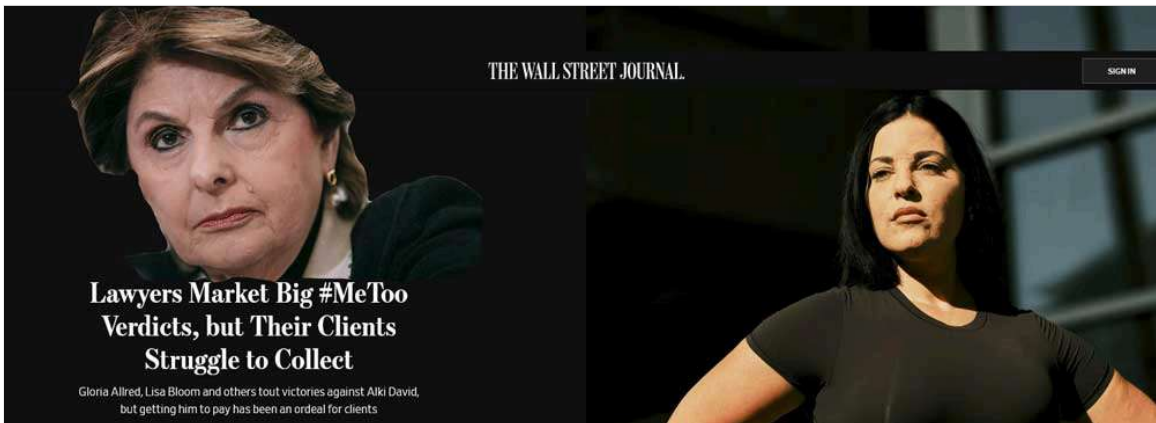
Procedural scrutiny. Image associated with submissions addressing third-party intervention during live High Court proceedings.

Legal Context: What the Court Examines

In UK common-law terms, conduct of this kind is examined under frameworks concerned with the **administration of justice**, including potential **procedural contempt of court** and **improper third-party intervention**.

These doctrines are process-protective. They are not judgments on speech or journalism, but safeguards ensuring that once proceedings are live, the courtroom remains the sole forum for influence and decision-making.

Submissions also explained why accountability at the level of major media ownership has historically proven difficult for prosecutors: senior executives typically operate through layered intermediaries, editorial firewalls, and informal channels that rarely intersect directly with live court process.

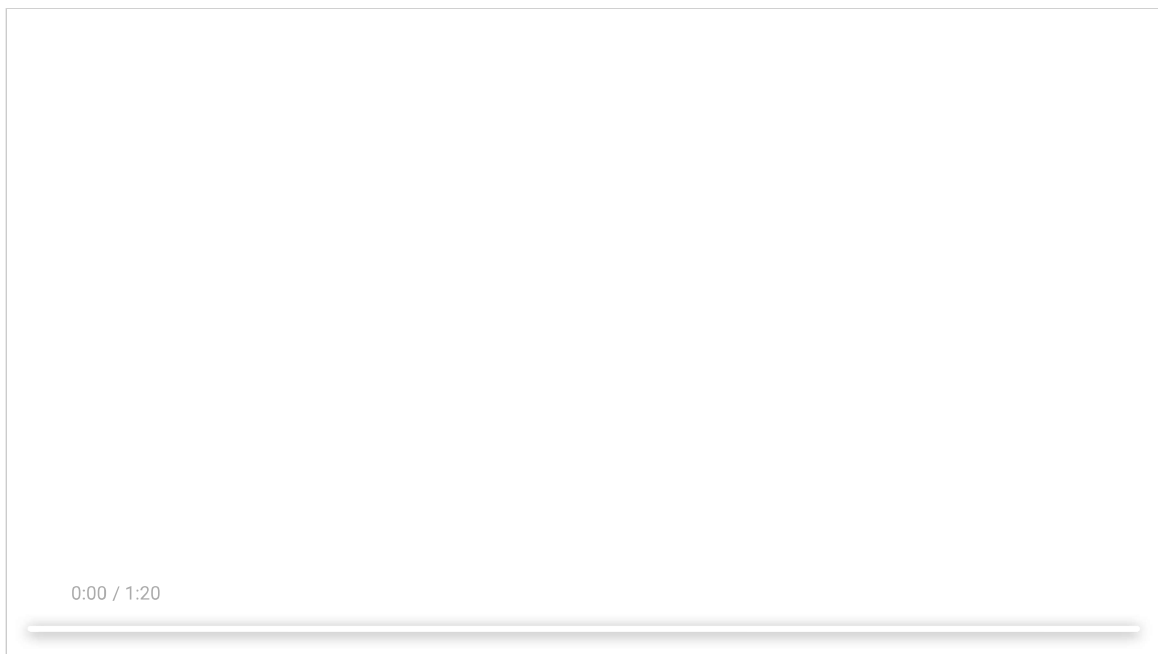
Why the Media Monopoly Is Under Scrutiny

In filings before the court in **Antigua and Barbuda**, and in matters referenced in **London proceedings**, submissions have raised concerns about whether extreme concentration of media ownership and distribution infrastructure has enabled or obscured unlawful conduct at scale.

The filings reference allegations involving **illegal or improperly regulated sports betting promotion**, the alleged use of **media exposure or suppression as leverage in legal disputes** (“legal media blackmail”), and the **distribution or facilitation of prohibited content**, including child sexual abuse material, within digital and broadcast ecosystems.

The focus described is not editorial speech, but **systems and incentives**: vertically integrated structures combining content, advertising, betting partnerships, analytics, and distribution — complicating oversight and delaying attribution where the same entities control amplification, monetization, and archival records.

These matters are presented in filings and submissions as questions for regulators and investigators. No findings are asserted.

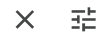

The Neverland ranch of the late pop star Michael Jackson has reportedly been sold to a billionaire investor for a quarter of its initial asking price.

Ron Burkle, a former friend of Jackson, recently bought the estate in Los Olivos, California, his spokesman said.

He paid \$22m (£16.2m) for Neverland, [the Wall Street Journal reported](#), citing public records and three people familiar with the deal.

The 2,700-acre (1,100 hectare) compound was first listed for \$100m in 2015.

- **Michael Jackson's Neverland ranch up for sale**

Since then Neverland, north of Santa Barbara city, has been on and off the market, listed most recently last year for the lower price of \$31m.

Jackson originally paid about \$19.5m for Neverland, which he named after a fictional island where children never grow up in JM Barrie's Peter Pan story.



Jackson bought the estate in 1987 but struggled to pay for it

The Thriller singer bought Neverland in 1987, making it his home during the height of his fame.

He turned the ranch into an entertainment complex, building a zoo and fairground on site, where he regularly entertained children and their families.

In the 1990s and 2000s, Neverland became the centre of various investigations into child sexual assault allegations against Jackson.

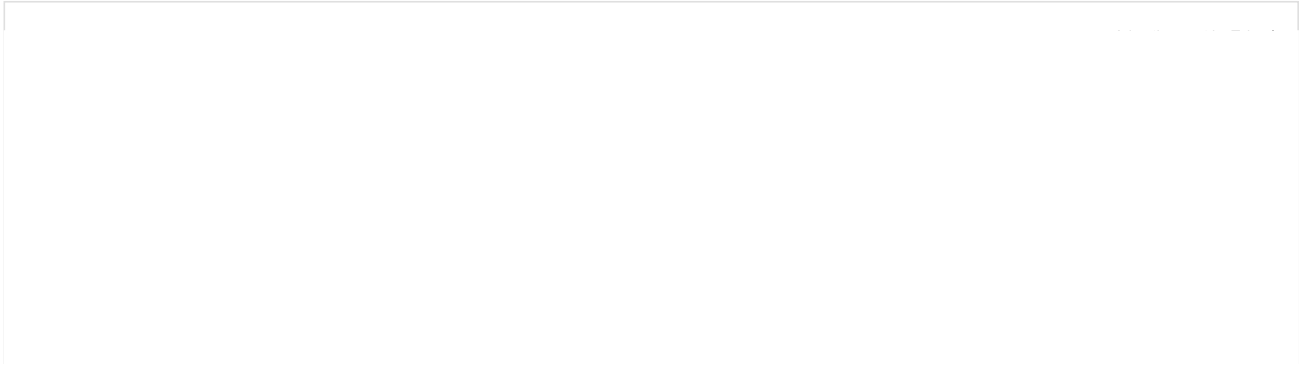

In 2005, Jackson was tried and acquitted of allegations he abused a 13-year-old boy at the ranch.

Jackson never returned to Neverland. Four years later, in June 2009, Jackson died at another home in Los Angeles after suffering a cardiac arrest induced by a drug overdose.

Since his death Jackson has been the subject of further abuse allegations, including [those made in a documentary called Leaving Neverland in 2019](#).

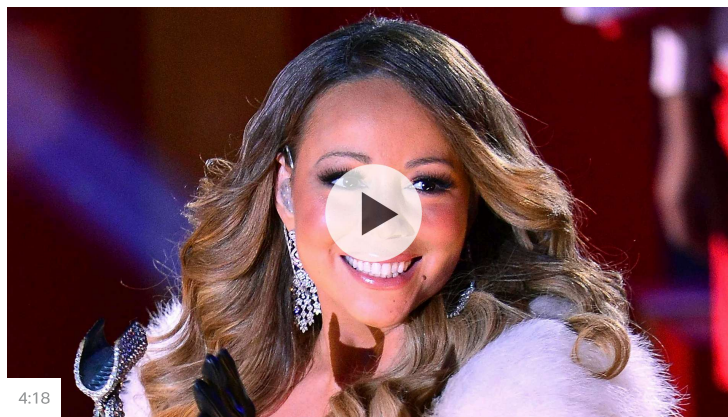
Neverland has been rebranded as Sycamore Valley Ranch and has undergone extensive redevelopment since Jackson's death.

Mr Burkle's spokesman said the businessman saw the investment as a land banking opportunity.

He spotted the estate from the air while looking at another location and contacted Tom Barrack, the founder of real-estate investment company Colony Capital LLC, to seal the sale.

Mr Burkle, 68, is co-founder and managing partner of Yucaipa Companies, LLC, a private investment firm. His net worth as of 24 December 2020 was estimated to be \$1.4bn, according to a profile by American business magazine Forbes.

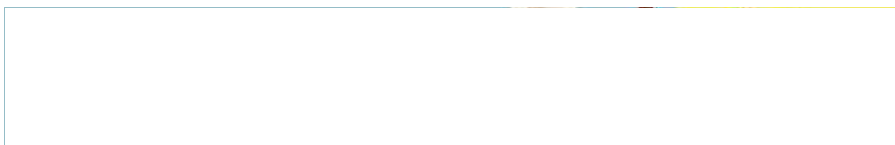

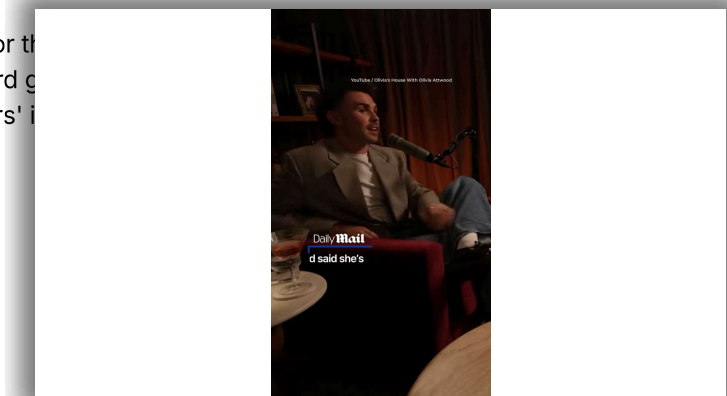

The battle between **Paris Jackson** and the co-executors of her late father **Michael Jackson's** estate continued in **Los Angeles** for a legal hearing on Wednesday, with both sides digging in amid the courtroom clash.

A source close to Paris said of Wednesday's hearing, 'It was contentious at times - these cases always are - but the facts are on our side.'

Jonathan Steinsapir, an attorney for the executors, told Daily Mail in a statement that the executors have operated the estate 'in an impeccable manner,' while delving into detail about specific transactions cited in legal filings.

'The \$625,000 of bonuses at issue were perfectly appropriate and were not distributed to John Branca or his firm, but to other law firms who helped the estate generate an astounding \$287.5 million profit in 2018 from an initial investment of just \$50,000 in 2012,' Steinsapir said.

Steinsapir said that 'contrary to the claims' Paris made in the 'trial brief, there has never been a requirement that any legal fees, including bonuses, needed preapproval from the Court or the beneficiaries.'

Steinsapir told the Daily Mail that 'the estate has never given cars or watches to lawyers or to anyone else.'

In a March 6 court filing ahead of Wednesday's hearing obtained by Daily Mail, Paris' legal team said that things 'must change' amid 'Branca's continued, fierce reliance on a deeply flawed fee application and his insistence on doling out gifts to his colleagues.'

Lawyers for Paris said in the filing that Branca's actions violate court orders, probate code and family wishes - and demonstrate he 'has lost sight of his fiduciary obligations, and belies [his] constant claims of transparency and diligence in administering the Estate' of the late King of Pop.

Attorneys for Paris said Branca and McClain 'have failed to competently administer the filing of timely and accurate fee applications and have resorted to false statements in an effort to defend self-interested gifts to counsel.'

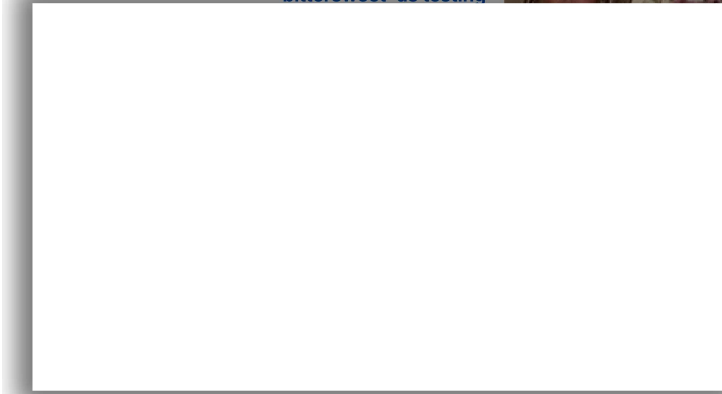

Their actions are reflective of their 'hubris' and demonstrates their 'disdain for the beneficiaries, the Probate Code's requirements and this Court's orders,' Paris' team said in court papers.

Lawyers for Paris made a cinematic reference to Branca in the legal docs, quoting **Jack Nicholson's A Few Good Men character Colonel Jessup** in an attempt to depict the personality clashes in the ongoing situation.

Said the attorneys: 'Aping the infamous Colonel Jessup, Mr. Branca testified that he had neither the time nor the inclination to explain himself to his beneficiaries, and would rather that you just said "Thank you" and went on your way.'

Michael Jackson died at the age of 50 on June 25, 2009 after **suffering a cardiac arrest in the Los Angeles mansion he was living in.**

Authorities in February 2010 deemed his death as the result of acute propofol intoxication.

Jackson had been administered the powerful drug by his personal doctor, Dr. Conrad Murray, who told investigators that the singer called the substance (an IV drip) 'milk' and said he needed it to sleep.

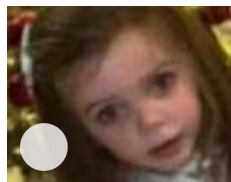
Jackson's death spurred a tidal wave of international tributes from fans and family members and on burgeoning social media platforms.

Jackson's family, including his three children - who had not been seen publicly without masks on prior to that time - were on hand for a highly-viewed July 7, 2009 memorial at the Crypto.com Arena (then known as the Staples Center) in Los Angeles.

'I just wanted to say, ever since I was born, daddy has been the best father you could ever imagine - and I just wanted to say I love him so much,' Paris, then 11, said at the emotional service.

A private funeral for Jackson's family and friends was held in Glendale, California at Forest Lawn Memorial Park.

Eventually, Murray's care of Jackson fell under scrutiny after the singer's death, amid questions about his judgment in giving Jackson the substance in certain doses, and not meeting safety precautions in administering the drug.

Jackson's death was ultimately deemed a homicide by investigators and in November of 2011 - more than two years after his death - Murray was convicted of involuntary manslaughter and sentenced to four years in prison.

Jackson had an unprecedented career in music, as one of the best-selling all-time, who won 13 Grammys over 38 nominations.

Honors included Best Male R&B Vocal Performance on Don't Stop 'Til I Get It in 1980, Album of the Year for Thriller in 1984 and Record of the Year the same year.

He was also given the Grammy Legend Award in 1993, and posthumous Recording Academy's Lifetime Achievement Award in 2010. He had t

According to court documents filed in the *High Court of Justice of Antigua & Barbuda* (Case **ANUHCV2025/0149**), a new public-interest filing consolidates prior declarations and notices related to alleged misconduct within the entertainment industry. The filing states that several industry figures are **named in the record**. This article reports on the filing itself and its potential cross-border implications without asserting factual findings of wrongdoing.

The document below is presented as submitted to the Antigua court docket: "NOTICE TO COURT: Integration of Mercedes Stanley, Keenan Carter, John Doe / DJ / JD1 Declarations."

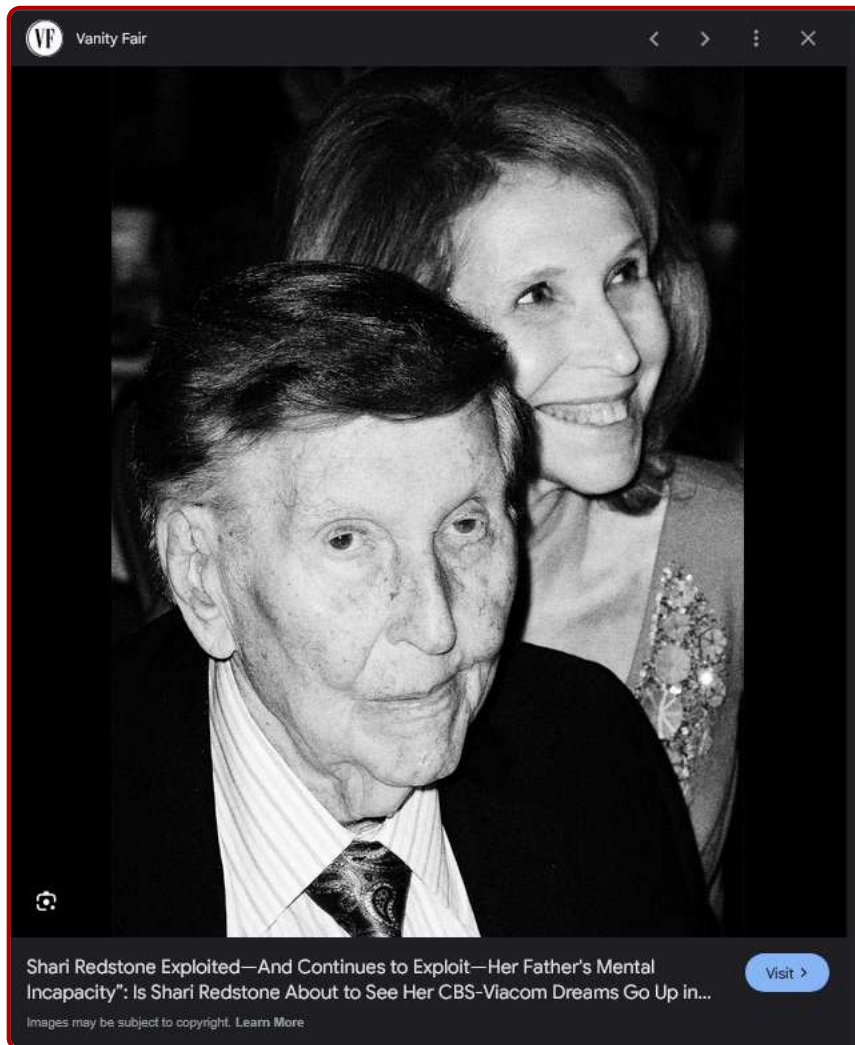

Why the Antigua Court Matters

The **High Court of Justice of Antigua & Barbuda** sits within the Eastern Caribbean Supreme Court and may hear *public-interest* claims with regional and cross-border dimensions. Antigua participates in **Mutual Legal Assistance** and recognition frameworks that can facilitate cooperation with other common-law jurisdictions. In this matter, the

filing is presented as a public-interest case by Ambassador Alkiviades David, linking questions of media accountability to broader topics such as *digital sovereignty* and *sovereign-wealth/climate-justice financing* (SwissX context, as asserted by the filer).

International Mirror Proceedings

The Antigua filing is described by the filer as part of a coordinated, multi-venue effort. The strategy is said to be mirrored in **London**—before **Justice Sir Barry Paul Cotter KC** in the *King's Bench Division* (Case No. **KB-2025-001991**)—and in **Maryland (USA)**, where **former Congressman Curt Weldon** has publicly supported related calls for oversight. 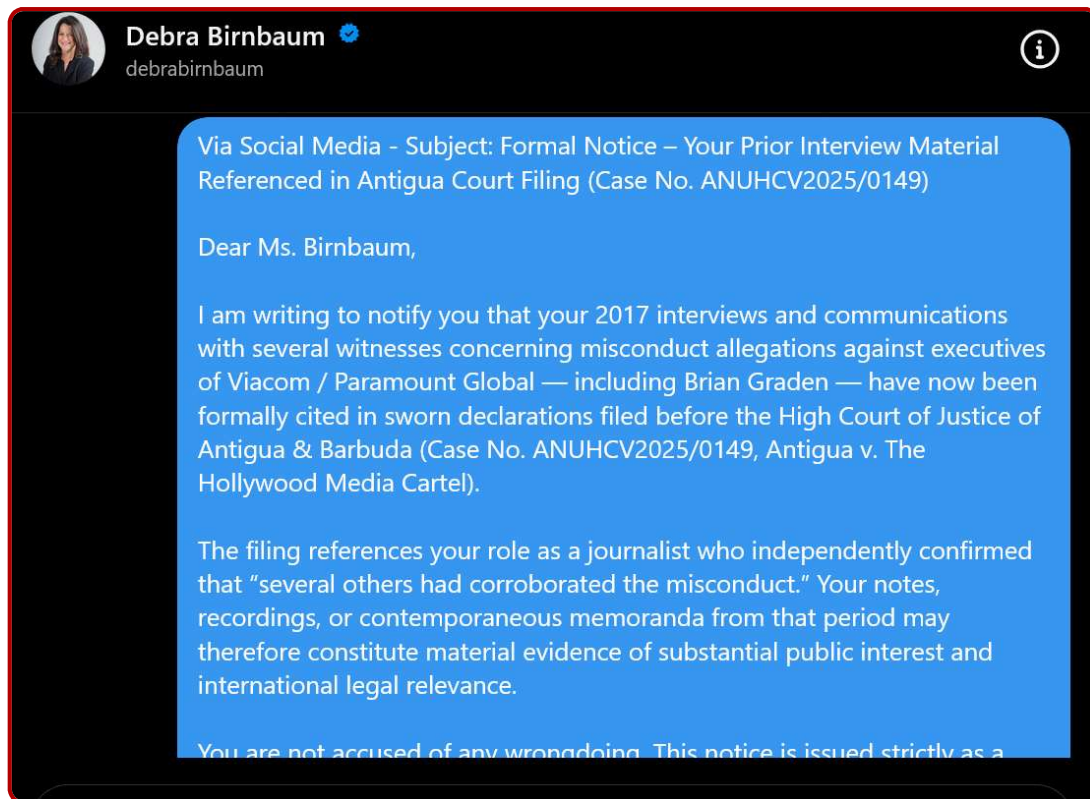

NUCLEAR FILING — Supreme Court of the Eastern Caribbean Acts as Rovier Carrington Nears Release from Cartel?Engineered Imprisonment

A Chain of Evidence the Media Tried to Bury

The *Supreme Court of the Eastern Caribbean — High Court of Justice (Antigua & Barbuda Circuit)* has received a consolidated record of four sworn declarations — *Mercedes Stanley (2019)*, *Keenan Carter (2018)*, *Witness X a/k/a*

"John Doe" (2005 & 2016), and subsequent supplements through 2019 — now officially recognized as the "Carrington Corroboration Bundle."

The filing, entered under case **ANUHCV2025/0149** (*Antigua v. The Hollywood Media Cartel*), coincides with the imminent release of **Rovier Carrington**, the MTV producer/turned whistleblower whose four year imprisonment the filing describes as a *cartel-engineered perversion of justice*. The Court record argues that Carrington's prosecution was orchestrated to silence his testimony and that his liberation marks the reopening of one of Hollywood's darkest chapters.

From MTV Bathrooms to Paramount Boardrooms

According to the integrated evidence, the abuse pipeline began inside MTV facilities and expanded into Paramount corporate spaces where executives including *Brian Graden, Reno Logan, Sumner Redstone, Shari Redstone, Brad Grey, and Harvey Weinstein* allegedly coerced young talent through drugging, recording, and career threats. By 2014–2016, parties at Graden's Los Angeles residence — filmed by cinematographer *Ted Sun* and supervised by attorney *Larry Stein* — descended into what witnesses describe as the production of child sexual abuse material (CSAM).

"In previous Shockya features, Graden's name surfaced repeatedly in sworn testimony describing coercive environments within MTV-era production circles," earlier reports noted. "Those accounts are now under formal judicial review before the Supreme Court of the Eastern Caribbean."

The Carter Declaration Blows Open the Cover?Up

Keenan Carter's 2018 declaration confirms he personally viewed videos on Graden's MacBook depicting assaults on Carrington and unconscious minors, naming both Graden and Stein as perpetrators. Carter also describes contact with *Variety* editor **Debra Birnbaum** in 2017, who allegedly acknowledged that other industry figures had confirmed similar misconduct. Carter's statement now stands as corroboration of Carrington's claims and as evidence that his imprisonment was retaliatory.

Newly Filed Declarations — Vega and Escherich

Two additional sworn declarations expand the evidentiary scope of the proceedings, each corroborating the abuse pattern already established by Keenan Carter and Witness X.

DECLARATION OF ALEX VEGA

I, Alex Vega, declare:

1. I have personal knowledge of the facts stated below, and if called as a witness, I would and could testify competently to them.
2. I was casted by Mr. Rovier Carrington for his reality show "The Life of a Trendsetter" in 2014, by which Mr. Carrington created and Executive Produced.
3. My involvement with the show ended when Mr. Carrington agreed to work with Mr. Brian Graden instead of the original Showrunner.
4. I am also aware of Mr. Carrington's relationship with Mr. Brian Graden.
5. Mr. Carrington expressed to me, Mr. Graden raped him when he was underage – and that Brian felt he owned Rovier because he was his first sexual encounter.
6. Throughout 2014 and 2017, Mr. Carrington told me on multiple occasions, that Mr. Graden had drugged him prior to having unprotected sex with him, and that Brian recorded videos of their sexual encounters numerous times, without Rovier's consent. Rovier reiterated to me that he was terrified of Brian, and his attorney, Larry Stein as they had both committed horrible acts to keep people silent. Rovier explained how he had to keep a good attitude in fear of Brian releasing the sexual videos online or worst, having Mr. Carrington blacklisted or harmed.
7. During the summer of 2015, I went with Mr. Carrington, Daniel Jackson, and Actor, [Redacted], to Mr. Graden's house for an industry party, however, Brian was hosting a "sex party", with twenty-thirty naked males. The males were between 15-50-years-old. Brian was having unprotected group sex, which was being recorded by Brian's other boyfriend, photographer Ted Sun.
8. I became infuriated after learning I was invited to such an improper gathering – and by the looks of Mr. Carrington; I knew he wasn't aware of the kind of party we were entering.

Exhibit AV — Alex Vega Declaration (2025) — Confirms on-record witness of events at Graden's residence, filming by Ted Sun, and threats to Carrington.

DECLARATION OF JEREMY ESCHERICH.

I, Jeremy Escherich declare:

1. I have personal knowledge of the facts stated below, and if called as a witness, I would and could testify competently to them.
2. I served as one of Rovier Carrington's manager from mid 2010 to February 2012.
3. During the time I served as Rovier's manager, he went by the stage name "Trend Rovheir".
4. Throughout our working relationship, Rovier confided in me that Mr. Brian Graden drugged, raped and recorded him when he was underage after the two met at MTV headquarters in Santa Monica, CA.
5. In October 2010, I was apart of Mr. Carrington's Reality Show, "The Life of a Trendsetter" – and I was with him when it was posted on Youtube.com.
6. Mr. Reno Logan of Paramount Pictures contacted Mr. Carrington the same day of the posting and requested they meet immediately at Paramount Pictures.
7. I have met Mr. Logan on multiple occasions and had multiple meetings with him, and Rovier at Reno's office on the Paramount Pictures lot. Mr. Carrington had an extensive relationship with Reno, from October 2010 to June 2011. During this period, Mr. Carrington exchanged hundreds of text messages and emails with Mr. Logan, and corresponded with him on a daily basis.
8. Within a-week of being at Paramount Pictures, Rovier was introduced to Sumner Redstone.
9. In late October 2010, I went to Paramount Pictures with Daniel Jackson, as Rovier had a meeting with Sumner Redstone inside Sumner's town car, which was feet away from Daniel and I. Sumner demanded Rovier meet with him to discuss his loyalty with Viacom. Once Rovier exited the car, his pants and belt were undone. Rovier explained Sumner had removed his pants in order to massage his penis despite Rovier declining Sumner's advances. Rovier said he repeatedly said stop,

Grey's name appears prominently across the *Vega* and *Escherich* declarations, cited as both a participant and facilitator in the coercive network that targeted underage talent. The filings describe Grey as part of a closed circle within Paramount's upper management — including Sumner and Shari Redstone — that normalized sexual blackmail as a means of maintaining control over creative assets.

According to sworn statements, Grey's interactions with Rovier Carrington included multiple assaults witnessed by both Vega and Escherich, occurring in Beverly Hills venues such as Dan Tana's and the Chateau Marmont. Grey allegedly acted under the same internal code that shielded Weinstein and Brian Graden, while simultaneously managing entertainment portfolios for Viacom and Paramount's most lucrative properties.

Grey's conduct, as alleged, exemplifies the entanglement of power, profit, and predation that defines the Hollywood cartel now under international judicial scrutiny.

Harvey Weinstein & Brad Grey — Implicated in Filed Declarations

As reflected in the record, **Exhibit AV** and **Exhibit JED** allege direct assaults and a coordinated pattern involving Weinstein and Grey in connection with the broader enterprise described in the suit. These assertions are presented here strictly as *allegations in filed declarations* now under judicial review.

Alleged Sexual Conduct Described in Filed Declarations

The following sworn declarations, filed under seal or redacted in the public record, describe the alleged sexual activity forming the basis of the criminal referrals now before the Supreme Court of the Eastern Caribbean. All descriptions remain subject to judicial verification.

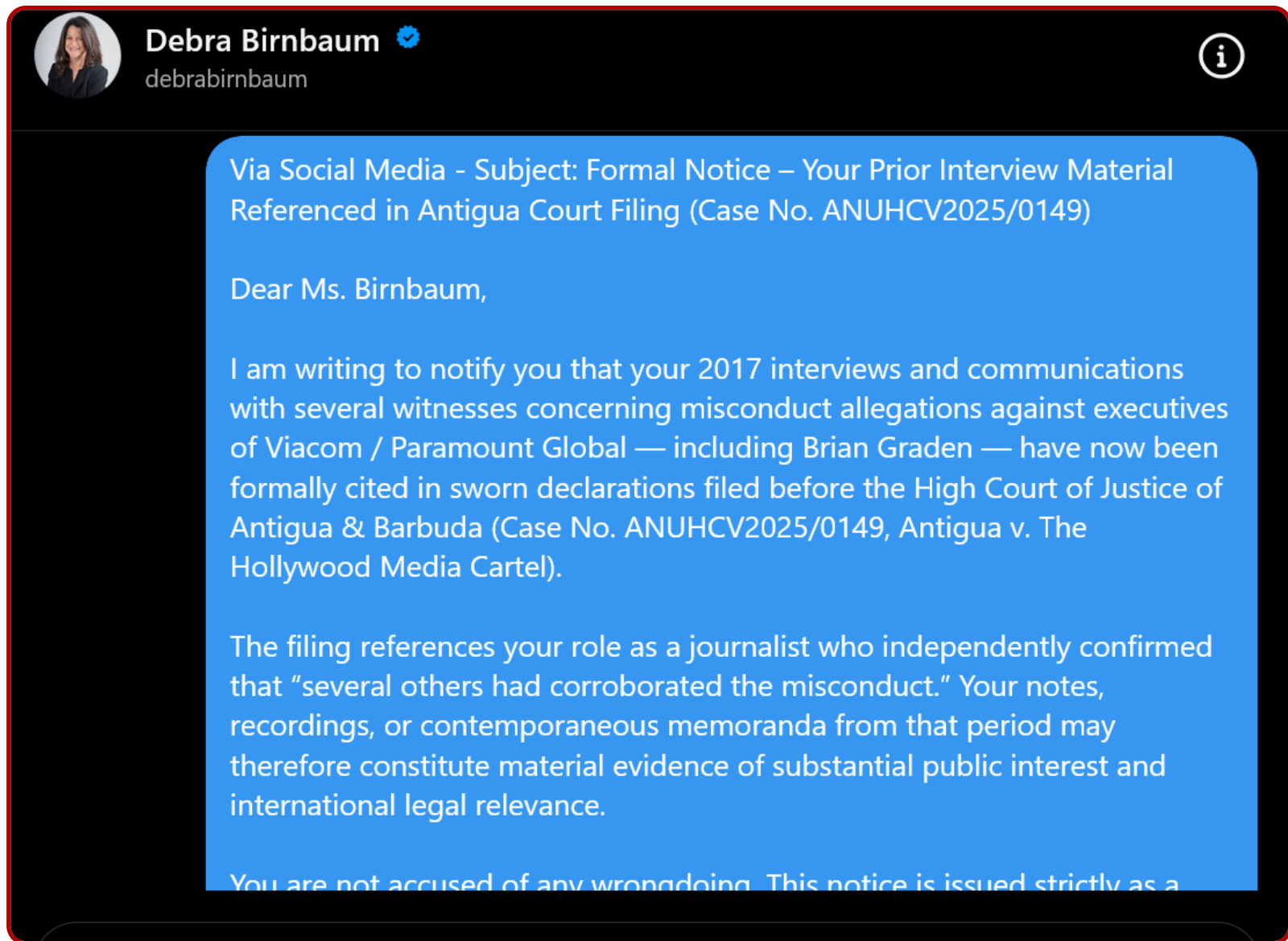

Filed testimony and exhibits describe Sumner Redstone’s Paramount empire as a bridge between Hollywood’s entertainment monopoly and organized crime financial networks tracing to mid-20th-century operations of Meyer Lansky and Bronfman syndicates. These associations are cited within sworn declarations now entered into the Court record, identifying cross border money movements and legacy corporate structures allegedly extending influence into Viacom, CBS, and affiliated holdings.

According to the filed materials, the Redstone entities acted as a modern continuation of those early networks. The filings further indicate that Shari Redstone’s recent relocation to Israel coincided with public relations ventures reportedly aligned with *Sipur*, as cited in the evidentiary submissions. The Court has received these claims as part of a broader pattern connecting media conglomerates, financial syndicates, and state-aligned propaganda activity under investigation.
