## **Another Girardi Judge Fakes Witness Testimony To Share In \$54 Million Order**

Justice **Elwood Lui** of the LA Superior Court — whose two sons also sit as judges on the same court — has been accused of **faking testimony** in a highly contentious trial so that he could benefit personally from a piece of a **\$54 million judgment**.

**“Mr. Shoefield did not provide testimony relating to his ex-assistant, Mahim Kahn, who he considers a ‘despicable liar.’”**

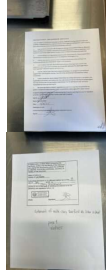

A colleague resigned due to harassment, prompting Khan to e-mail senior vice president Gary Shoefield in August 2015. Shoefield previously checked on Khan's well-being after David squeezed her breast. Khan mentioned the resignation and wrote, "I'm specifically worried about Alki [David] continually being sexual towards me. It makes it difficult to work here . . . . I can't stand him touching me anymore." When they met to discuss Khan's concerns, Shoefield knew about the harassment, but said David was "never going to change." **WRONGFUL TESTIMONY**

## "My due process was wrongfully and illegally taken away from me by Judge Michelle Williams-Court"

**Attorney Ellyn Garofalo**, who represented David at the time, said: "Williams-Court did not allow Mr. David witnesses, rebuttals, or any due process — nor that of his companies which I was representing at the time."

Girardi-judge Michelle Williams-Court was fast-tracked to the Superior Court of LA by Tom Girardi's "mini-bar."

**Attorney Amir Kaltgard**, working alongside Garofalo, added: "Williams-Court made many wrongful decisions, ignored irrefutable evidence of witness tampering, and even allowed falsification of Ellyn Garofalo's signature in one documented instance."

Whistleblower testimony further asserts that **Gloria Allred** arranged Tom Girardi to fast-track Williams-Court's application to the judiciary despite her two previous failed attempts. Williams-Court is considered another "Girardi Judge," first exposed in a *TV Mix* article when she reportedly sought Allred's help due to domestic abuse.

## Gloria Allred, Tom Girardi, and Their Loyola Network

Gloria Allred and Tom Girardi both graduated from Loyola Law School, along with Judge Victoria Chavez. Chavez, a former business partner of Judge Yolanda Orozco, also sat in with Lui. Orozco, called by many the "Money Launderer In Chief," became a critical cog in the Girardi machine.



Girardi Judge Yolanda Orozco retired 10 years early after being [exposed by Shockya and TVMix](#) as the “Money Launderer in Chief” for the Girardi Network. She kept Girardi and Sheriff Lee Baca in business during the peak of their criminality (2000–2017).

## The judgment itself has been contested for years by media mogul Alki David, who claims plaintiff Mahim Kahn lied and collaborated with Gloria Allred and Lisa Bloom to create fake #MeToo cases against him.

In November, the State Bar of California issued this

[Open Letter of Apology](#),

for the damage Tom Girardi's Hollywood Crime Syndicate inflicted on the public.

“

*“Girardi himself accused me of a rape that never happened. In fact, the accuser recanted. There is irrefutable evidence this was set up by the Girardi Network and ‘Jane Doe’ is now hiding in the Middle East where she is from.” — Alki David*

David added: “Girardi through Gloria Allred, Lisa Bloom, and Michael Avenatti (now serving 14 years) have targeted me and others for years.”

**“Others affected by the same gang of criminals include Rose McGowan, Steve Wynn, 50 Cent, and many more — Hollywood’s most notorious targets.”**

## Elwood Lui’s History of Scandal

Lui himself has been implicated before. A 2019

reported that Judge Johnson accused Lui of violating privacy rights during a harassment probe — an action that led to a \$10 million lawsuit.

Alki David — Publisher, Media Architect, SIN Network Creator - live, direct-to-public communication, media infrastructure, accountability journalism, and independent distribution. Born in Lagos, Nigeria; educated in the United Kingdom and Switzerland; attended the Royal College of Art. Early internet broadcaster — participated in real-time public coverage during the 1997 Mars landing era using experimental online transmission from Beverly Hills. Founder of FilmOn, one of the earliest global internet television networks offering live and on-demand broadcasting outside legacy gatekeepers. Publisher of SHOCKYA — reporting since 2010 on systemic corruption inside the entertainment business and its expansion into law, finance, and regulation. Creator of the SIN Network (ShockYA Integrated Network), a federated media and civic-information infrastructure spanning investigative journalism, live TV, documentary, and court-record reporting. Lived and worked for over 40 years inside global media hubs including Malibu, Beverly Hills, London, Hong Kong and Gstaad. Early encounter with Julian Assange during the first Hologram USA operations proved a formative turning point — exposing the realities of lawfare, information suppression, and concentrated media power. Principal complainant and driving force behind what court filings describe as the largest consolidated media–legal accountability action on record, now before the Eastern Caribbean Supreme Court. Relocated to Antigua & Barbuda and entered sustained legal, civic, and informational confrontation over media power, safeguarding, and accountability at Commonwealth scale.
