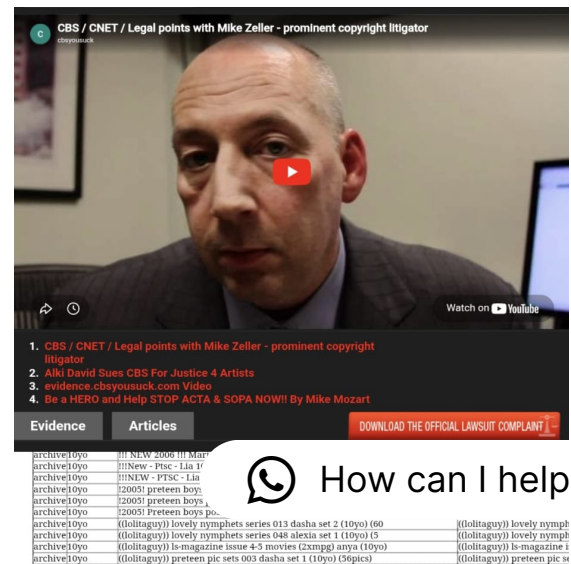
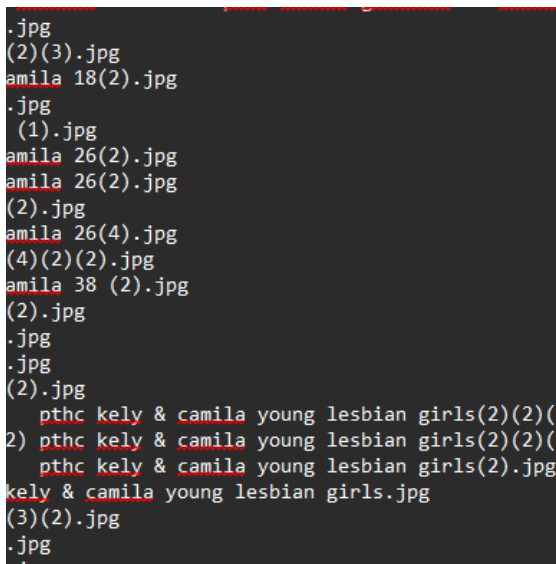
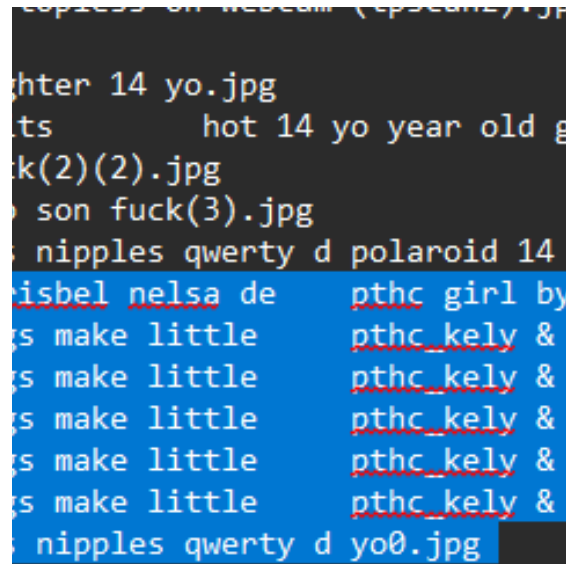


But the cult never died.

- 1. This addendum is advanced on a strictly protective basis and should be read together with the Application for Stay, the supporting affidavit / witness statement, and the exhibits already filed or tendered in support.
- 2. I do not invite the Judicial Committee by this addendum to determine every wider allegation or contextual matter said to arise elsewhere. The purpose of this addendum is narrower: to explain why the present proceedings, on my case, engage a wider sovereign and public-interest dimension extending beyond an ordinary private dispute.

**Asot Michael**

- 3. Asot Michael was very close to me and, as I have already placed on record, he was my partner in Antigua.
- 4. I rely on that fact not merely as personal background, but because the materials already exhibited identify a dated communications trail involving Asot Michael, Clark Hill, and Kingsley Napley, and request preservation of non-privileged factual records and metadata. That pathway reinforces the Antigua nexus and the need for preservation.
- 5. There are many others affected by the wider coercive patterns said to arise in the record, but for me the matter is also deeply personal. Asot Michael was very close to me, and his murder demands justice.

**Prime Minister Gaston Browne and the Parallel Sovereign-Facing Context**

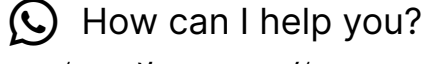
- 6. I further say that related sovereign-facing litigation has also arisen involving Prime Minister Gaston Browne and Antigua and Barbuda.
- 7. In the SDNY Alfa Nero matter, Prime Minister Gaston Browne was among the movants who sought to quash subpoenas directed at financial records said to bear upon proceedings and sovereign interests connected to Antigua and Barbuda, and those motions were granted. I rely on that matter not to overstate identity of parties or posture, but to show that parallel litigation has already engaged sovereign-facing issues concerning Antigua and Barbuda.
- 8. I also rely on the public broadcast transcript in which Prime Minister Browne is recorded as characterising the related litigation as fabricated, a fishing expedition, and an effort to undermine Antigua and Barbuda. I do not rely on that as conclusive proof of every fact asserted there. I rely on it to show that the wider dispute has already acquired a public sovereign and reputational dimension affecting Antigua and Barbuda as a nation.

**Executive note.** This memorandum does not allege wrongdoing by any lawyer or firm. Its purpose is to preserve a factual communication trail that may assist lawful timeline reconstruction, witness identification, and non-privileged document tracing.

**1. Purpose**  
 This memorandum is submitted to assist any lawful investigative assessment concerning communications, intermediaries, and professional-service channels connected to the late Asot Michael.  
 The purpose is narrow and procedural: to preserve a factual chronology, identify a potentially relevant UK nexus, and flag non-privileged lines of inquiry that may assist investigators.

**2. Core Point**  
 A review of my email records shows that Asot Michael was directly involved in facilitating contact between me and legal professionals, including a London law-firm contact and a United States law-firm channel.  
 The significance is not the mere presence of lawyers. The significance is that this trail may help reconstruct who was communicating with whom, when those communications occurred, the purpose of the introductions, whether documents were transmitted, and whether meetings or calls were arranged.

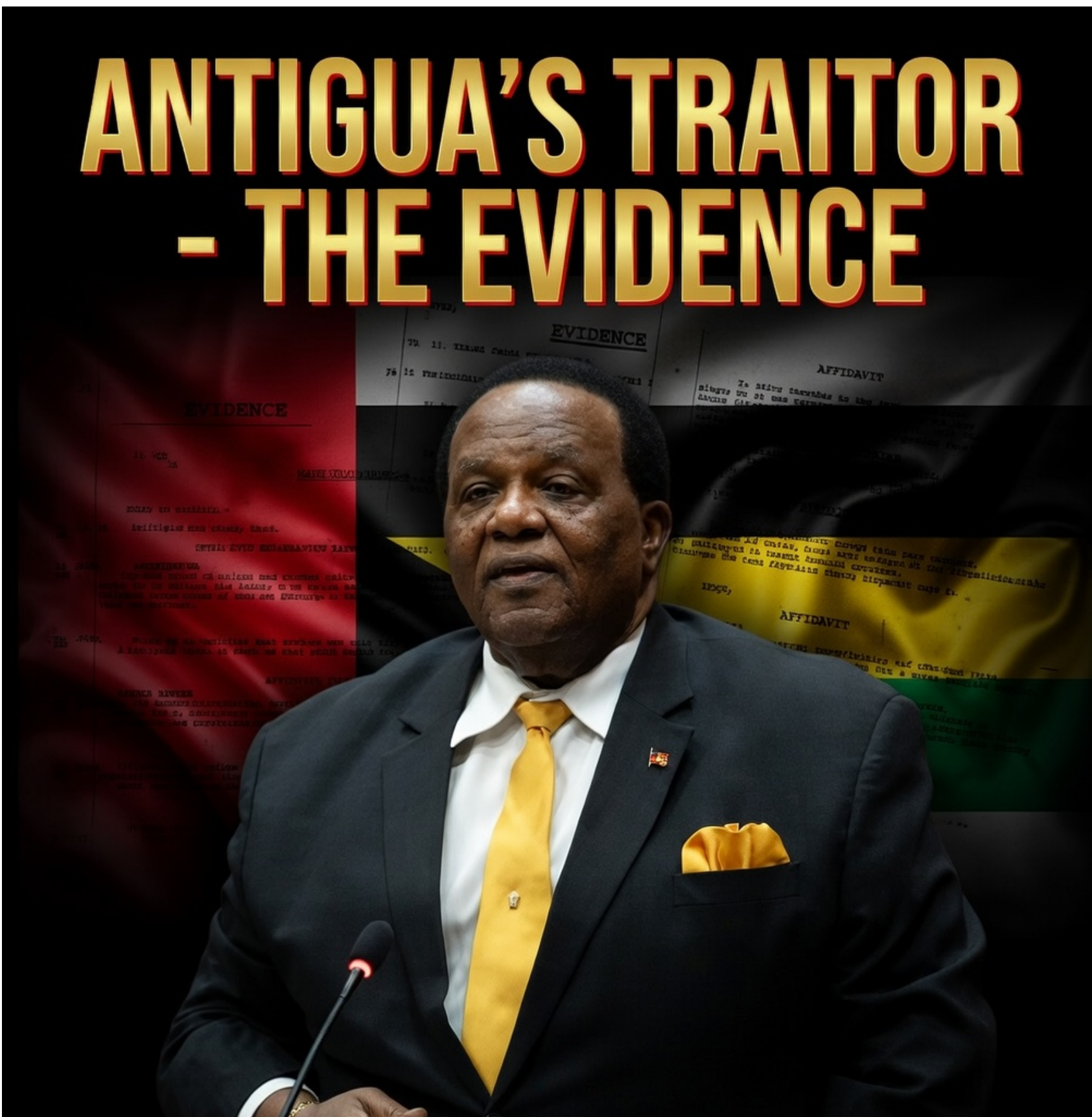

An Act to establish a legal framework for the generation, verification, registration, and trading of carbon credits within Antigua and Barbuda, and to align national carbon market mechanisms with the country's Nationally Determined Contributions (NDCs) under the Paris Agreement.

1. Short Title

This Act may be cited as the Carbon Compliance Market Act, 2025.

2. Purpose

The purpose of this Act is to establish Antigua and Barbuda's national compliance carbon market, regulate carbon credit issuance and trade under Article 6 of the Paris Agreement, and promote investment in blue-carbon and green-carbon projects.

3. Definitions

Carbon Credit means a tradable certificate representing one metric ton of carbon dioxide reduced, sequestered, or avoided. Authorized Project Developer includes entities licensed by the Ministry of Environment, such as the SwissX Sovereign Wealth Fund.

4. Establishment of National Carbon Market Authority

There is hereby established a body corporate known as the Antigua and Barbuda Carbon Market Authority (ABCMA). The Authority shall oversee certification, approve methodologies, and coordinate with the UNFCCC.

5. Authorization of Project Developers

The Minister may designate qualified entities as Authorized Project Developers responsible for MRV and community benefit sharing.

6. Eligible Projects

Projects qualifying for compliance credits include blue-carbon restoration, biochar, regenerative agriculture, renewable energy, and waste-to-energy initiatives.

7. Verification and Certification

Verification must be conducted by an accredited Designated Operational Entity (DOE). Certified credits shall be recorded in the ABCR with full traceability.

8. Ownership and Transfer

Carbon credits are recognized as financial instruments. Ownership vests in the project proponent unless otherwise specified.

He says it has become a live test of institutional transparency, evidentiary preservation, and whether courts and public bodies will confront allegations of coordinated abuse of process, concealment, and systemic protection of powerful interests.



A number of individuals and entities are named across David's wider filings, repository materials, and public allegations. Those references should be understood as allegations and matters said to require investigation.

**Application**

The Appellant / Applicant, Alkiviades David, applies for urgent interim relief pending determination of the appeal and related procedural matters.

**Order Sought**

1. An immediate stay of enforcement pending further order.
2. Preservation directions in respect of non-privileged factual records, metadata, communications, device-derived materials, and related evidential pathways relevant to the appeal and to the matters identified in the accompanying witness statement.
3. Such further case-management or protective directions as the Judicial Committee considers just.

**Grounds**

4. The Applicant has made repeated stay requests below and says that no substantive determination has removed the practical prejudice caused by continuing enforcement.
5. The Applicant says the appellate record has been materially incomplete and that material going to contradiction, inconsistency, and fairness was not deployed.
6. The Applicant is a disabled litigant with a traumatic brain injury and relies on the accompanying medical materials in support of the need for reasonable adjustment and procedural protection.
7. Enforcement has moved into a second phase. The Applicant relies on third-party evidence said to show interference with devices and records, including the seizure of an iPad and DVR on 1 June 2023, even though the declarant was not the judgment debtor.
