Subject: Update on Connected Appeal in London, Summary Judgment Grounds, and Request for Multiplicative Damages

I write respectfully to update the Court on the connected appeal presently before the Court of Appeal (Civil Division) in London, under reference KB-2025-001991, where I appear as Appellant before a three-judge panel. This appeal concerns clear and repeated instances of fraud upon the court, concealment of evidence, and financial misrepresentation of damages by the respondent attorneys, who deliberately suppressed material that had already been filed before Your Lordship in Antigua and later dismissed it as “vexatious.” For the record, Mr Justice Cotter read my entire skeleton argument aloud on 25 July 2025, confirming its merit and public-interest importance. The London appeal now proceeds on the same foundation: the respondents’ deliberate deception and bad-faith litigation designed to obscure truth and pervert justice. Your Lordship may recall that in an earlier exchange, I said “it was never about the money,” and you observed, “in hindsight, it is always about the money.” I acknowledge the wisdom of that statement. My purpose, however, remains the same—to correct the record, not enrich myself. I could have ended this matter years ago for a few hundred thousand pounds, but my late father, Andrew A. David, the first and only white man ever honoured as a Babalági (Chief Priest) of Egbaland, Nigeria, taught me that truth and justice cannot be compromised. His legacy was built on moral courage and cultural unity, and today his good name has been irreparably harmed by the lies and manipulations of this global media cartel. These defendants have been repeatedly notified of these court proceedings, both through formal service and direct correspondence, yet they have ignored every opportunity to respond. In particular, Shari Redstone, as principal and controlling shareholder of Paramount Global, has been served twice—a “double service”—leaving no doubt that their continued silence is deliberate and contemptuous. The evidence of service and willful non-participation establishes grounds for summary judgment. Accordingly, I respectfully urge the Court to consider multiplicative damages—in alignment with U.S. RICO standards—where treble (x3) and, in cases of grave medical or humanitarian injury, quintuple (x5) damages are warranted. The scope of injury in this case transcends personal or corporate harm, encompassing cultural, reputational, and ecological devastation—the cumulative effects of a criminal enterprise that has undermined the moral and informational fabric of entire nations. Despite repeated publications, public demonstrations, and wrongful arrests in London linked to the same \$900 million judgment (reported by the Daily Mail and others), there remains systemic silence across mainstream media. That silence itself is evidence of the monopoly—four interlinked family dynasties controlling 85 percent of the world’s news narrative—a structure now squarely challenged in this Court. I remain associated with

Bohm & Wildish LLP in California and continue preparing a RICO action in Maryland with Senator Curt Weldon, with the knowledge of the DOJ and President Trump, who also see these channels as an evil in America. I have also enclosed a video of my broadcast with David Lester Payne on Observer Radio Antigua, where I outlined these developments and the significance of Your Lordship's leadership in this landmark case. Your Lordship, I must also place on record my present financial hardship. Although I possess significant assets, my accessible cash has been effectively stolen or frozen through ongoing misconduct, which I am presently addressing before the courts in London. As a result, I have been starved of liquidity, relying solely on the goodwill of friends and family who continue to support this struggle for justice. This reality underscores the need for immediate and proportional relief from this Honourable Court. This lawsuit represents not merely a claim for damages, but a call to restore integrity to law, media, and governance. I remain deeply grateful for Your Lordship's continued courage and discernment in overseeing these proceedings, which I firmly believe will set a global precedent for truth and justice.
