Hi Alki,

I met with Jay and Donna yesterday to discuss the path forward for selling CinemaNow. We agreed that we were going to make a sprint push over the next month to try and get immediate traction and flip the asset. If we don't get any bites, then we might need to slow burn the sale until after we IPO.

In the short term, we have to keep the asset alive in order to sell it. We have already lost 75% of the studios, and need to keep the last few we have if we are to have any hope in selling the asset.

We have identified the critical bills below that we need to pay in order to keep the service functioning. Paramount is one of the main studios that we still have, and we just got them current so want to maintain that relationship. Them Premiere and IBM are for content delivery and are required in order to keep getting new movies and TV shows.

There is enough in the Chase account to get these paid, but if we make all of these payment it will essentially clear out the account and mean that FilmOn needs to float CN payroll for the next pay period. Can you please approve us to pay these studio/content bills?

In addition, please let us know if you want to pay one or several of them from the FilmOn account or have all come from the CN Chase account.
