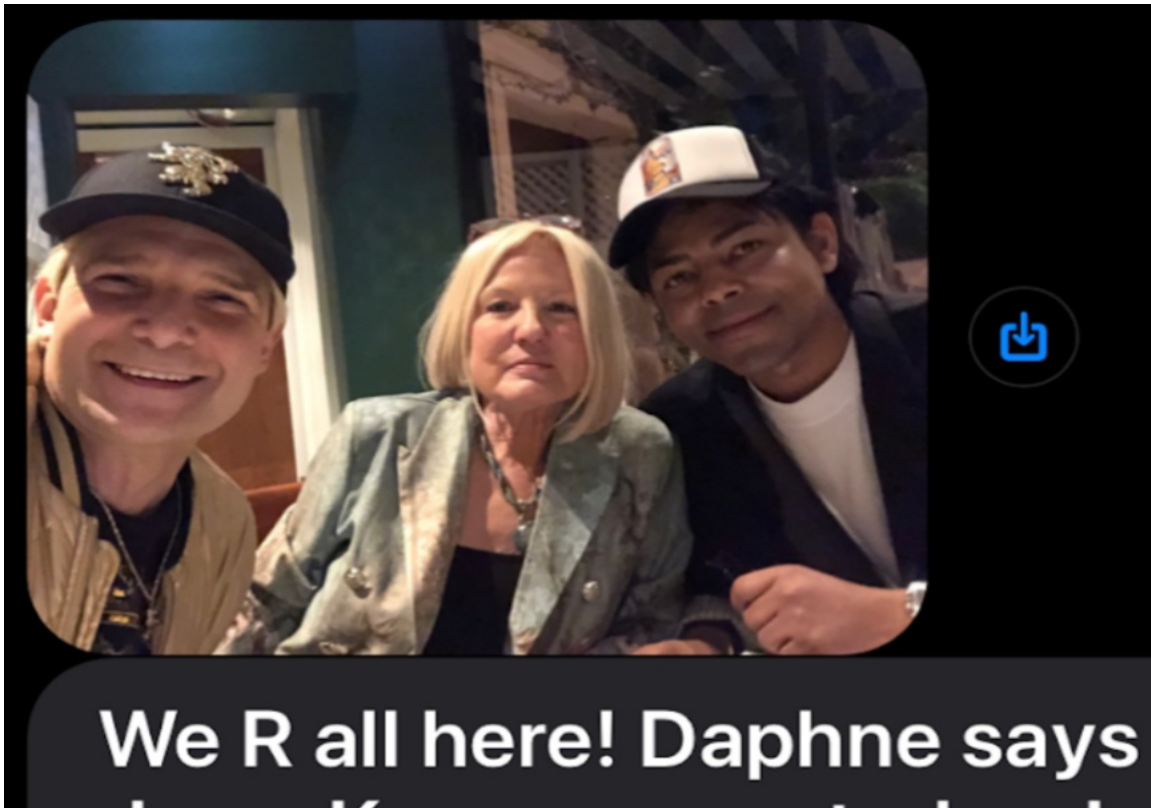

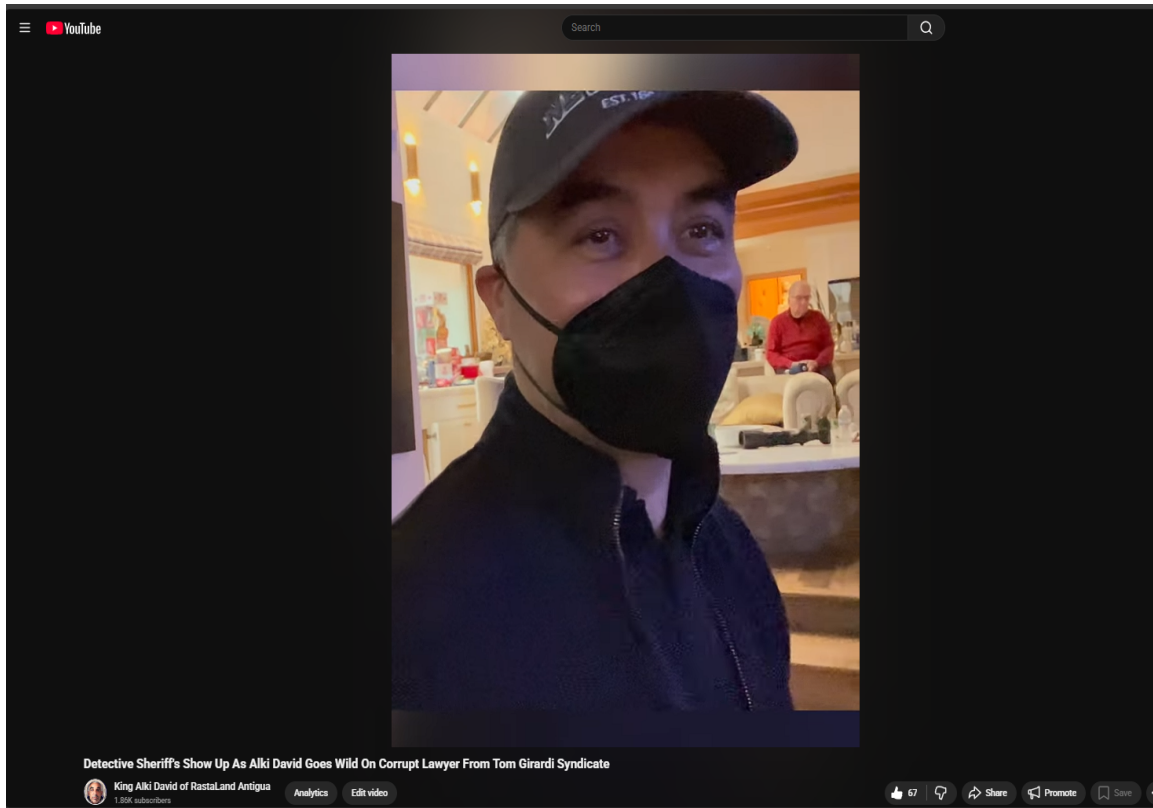


### Later career [edit]



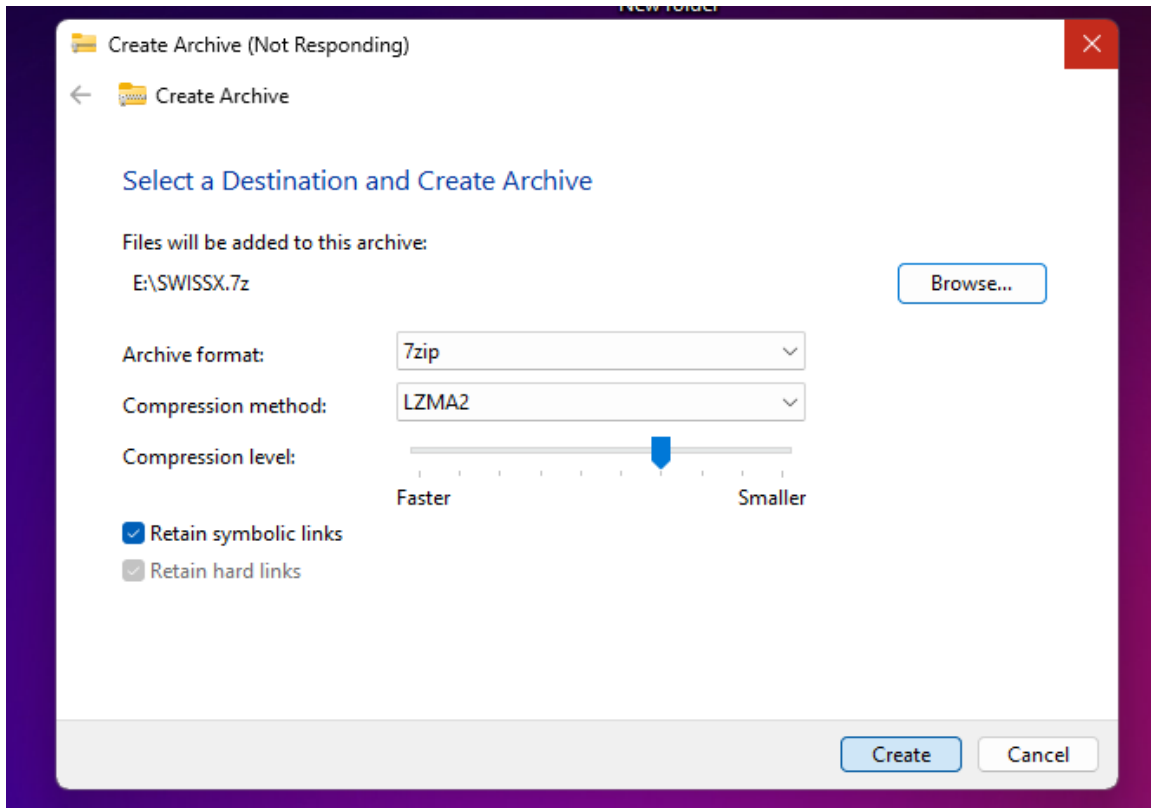

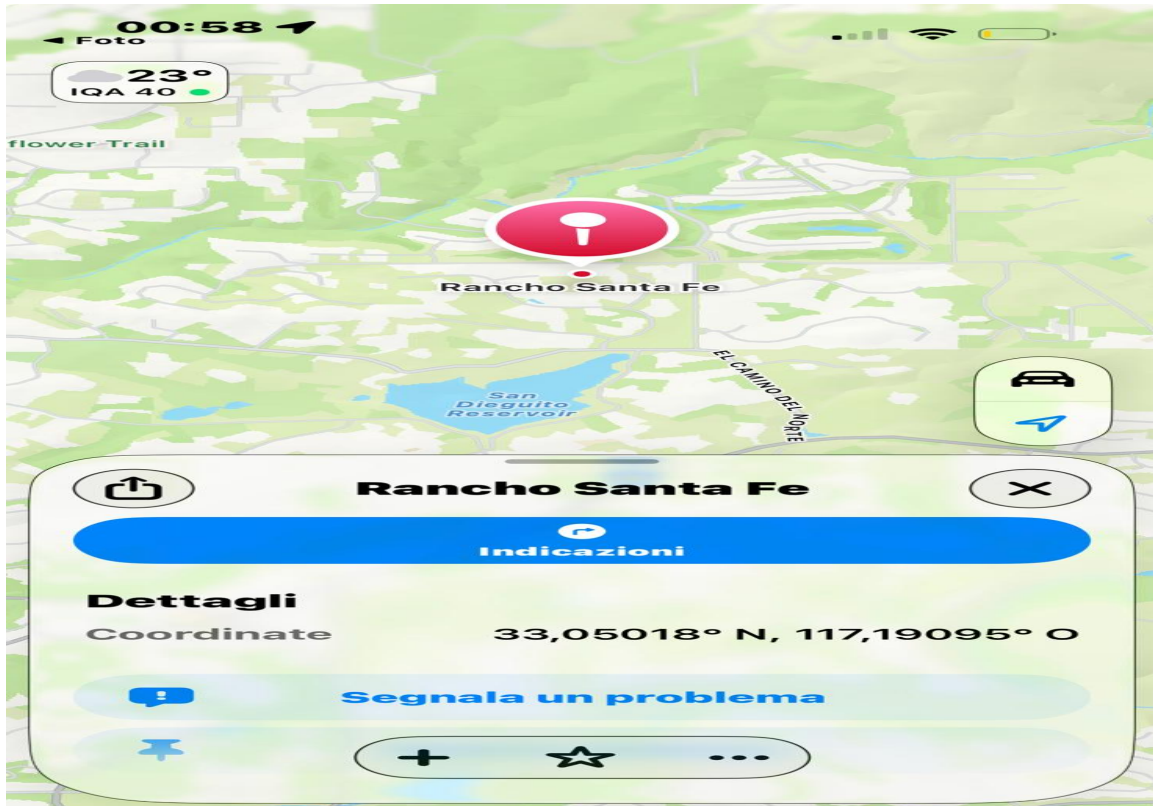
