

**SUPPLEMENTAL NOTE TO THE COURT
(Notice and Persistence After Notice)**

The Applicant respectfully appends a Public Notice dated **9 February 2026**, circulated and retained contemporaneously within the United Kingdom and wider Commonwealth information sphere.

The document is tendered **for notice purposes only**. It is relied upon solely to demonstrate that the subject matter of these proceedings, the institutional risks engaged, and the identity of the Respondents were already known, intelligible, and under active public and professional discussion prior to, and during, the Respondents' continued refusal to acknowledge service, appear, or otherwise engage with the Court's process.
