

SWORN DECLARATION OF ALKIVIADES DAVID

(Final Master Statement for the Record)

1. INTRODUCTION

I, Alkiviades David, of Saint John Parish, Antigua and Barbuda, make this declaration in support of the matters set out below.

I make this declaration with a heavy heart.

What I am about to set out is not distant, abstract, or impersonal. It reaches into my own life — into my family, my history, and relationships that I once believed were built on trust, loyalty, and protection. To speak about these matters publicly is a source of deep personal shame to me.

This is not something I ever wanted to do.

There is a natural instinct to protect one's family, to remain silent, and to hope that matters resolve themselves quietly. For a long time, I held onto that instinct. I tried to address these issues privately, to avoid bringing them into the open, and to preserve dignity where I could.

But I have reached a point where silence is no longer an option.

Because silence, in the face of what I have seen and what I can evidence, would make me complicit.

So I make this declaration not out of anger, and not out of vengeance, but out of duty.

A duty to the truth.

A duty to my children and those who depend on me.

A duty to the courts and to the proper administration of justice.

If the matters I describe involve people close to me — and in some cases they do — that does not lessen my obligation to speak. It makes it more painful, but also more necessary.

My shame is personal.

My duty is public.

And I now choose to fulfill that duty.

2. PURPOSE OF THIS DECLARATION

This declaration is made to consolidate my evidence into a single coherent record, preserve the integrity of materials already filed, set out the factual matrix as I understand it, identify patterns requiring investigation, and support judicial review and independent scrutiny.

3. BACKGROUND

I am the founder and operator of multiple media, technology, and intellectual property platforms, including FilmOn / Philmon, Hologram USA, and SwissX platforms and related systems. These assets are connected to broader structures, including the Harmonia Trust, which holds significant rights and interests relevant to these proceedings.

Over a prolonged period, I have experienced interference with business operations, disruption of contractual relationships, loss of control over key assets, and legal and procedural obstruction.

4. FAMILY AND PERSONAL CONTEXT

Elements of this matter involve my own family. This is the most difficult part of this declaration. I take no satisfaction in saying this. It is a source of shame, grief, and personal conflict. But I cannot allow family relationships to override my obligation to the truth.

5. CORE ASSERTIONS

I assert sustained interference with legal proceedings, evidentiary materials, and asset control structures, including alteration of filings, mischaracterization of evidence, and resistance to disclosure.

6. EVIDENTIARY STRUCTURE

This declaration is supported by documentary evidence, digital materials, and visual exhibits, each preserved under its original file name for evidential continuity.

7. DEFAULTS AND THEIR SIGNIFICANCE

Multiple parties failed to respond in Antigua proceedings, resulting in defaults which are material to the matters before the Court.

8. NEED FOR INVESTIGATION

There is a clear need for independent investigation, preservation of evidence, and review of procedural integrity.

9. REQUEST FOR RELIEF

I respectfully request preservation of evidence, independent review, judicial consideration of the full record, and such further relief as the Court deems appropriate.

10. FINAL POSITION

I would have preferred silence. But silence would be wrong. I therefore make this declaration fully aware of its seriousness and committed to the truth.

11. STATEMENT OF TRUTH

I believe that the facts stated in this declaration are true to the best of my knowledge, information, and belief.
