EXECUTIVE SUMMARY

This affidavit is presented to establish a comprehensive record of legal abuse, international judicial interference, and criminal misconduct that has culminated in my unlawful inclusion in the litigation concerning the vessel Alpha Nero. The facts presented herein illustrate a sustained, transnational campaign of retaliation aimed at silencing whistleblowers and protecting a global syndicate of media, legal, and intelligence actors.

I submit this affidavit as both a matter of self-defense and public interest, to aid this Honourable Court in recognizing the manifest injustice being attempted within its jurisdiction and the sovereign courts of Antigua and Barbuda.

BACKGROUND

I, Alkiviades David, am a British citizen, and full-time resident of Antigua and Barbuda. I am the founder of SwissX Sovereign Trust, FilmOn TV, and other lawful enterprises. My litigation history includes precedent-setting victories against CBS Interactive, DoubleVerify, and other legacy media conglomerates.

The retaliation against me stems from my role as lead plaintiff in multiple lawsuits exposing systemic facilitation of copyright fraud and child exploitation by CBS Interactive and CNET through their promotion of LimeWire, Grokster, and similar platforms. A key case, David et al. v. CBS Interactive (U.S. Dist. Ct., C.D. Cal., Case No. CV11-09437), was allowed to proceed on claims of inducement by Judge Dale S. Fischer. This ruling was widely covered and is enclosed herewith (EXHIBIT A).

Following this litigation, I became the target of a coordinated effort to destroy my business, reputation, and safety. This syndicate includes:

- David Boies, Boies Schiller Flexner LLP
- Gloria Allred, Lisa Bloom, Tom Girardi
- Fugitive Dani Peretz (Mossad-linked, wanted in Switzerland and Greece)
- Anthony Pellicano, Joseph Chora and Others.

I have survived multiple attacks on my life. Four of my attorneys—Rebecca Rini, Barry Rothman, Mark Lieberman, and John Quirk—have died under suspicious circumstances. All were in possession of, or seeking to admit, exculpatory evidence (EXHIBIT B: Mary Rizzo Text Messages).

The syndicate's actions have extended to the sovereign courts of Antigua, in a malicious attempt to interfere with lawful government and private sector partnerships involving the SwissX Sovereign Trust.

LEGAL GROUNDS FOR STRIKING AND STAYING PROCEEDINGS

I. INTERNATIONAL LIS PENDENS AND COMITY

The litigation pending before the Eastern Caribbean Supreme Court—Alkiviades David v. David Boies et al. (ANUHCV2025/0149)—involves the same factual nexus and core parties. This Court is obligated under doctrines of lis pendens, comity, and procedural fairness to halt any further

proceedings in overlapping matters.

II. ADA VIOLATIONS

As a qualified individual under the ADA with a diagnosed TBI, I have not been afforded accommodations, in violation of federal and state law (Title II, ADA; Cal. Civ. Code § 54.8).

III. FRAUD ON THE COURT

Exculpatory materials were deliberately suppressed. Key evidence (EXHIBIT B) invalidates the claims against me. The fraudulent conduct of opposing counsel and complicit court officers mandates vacatur under Cal. Code Civ. Proc. § 473(d).

IV. PENDING CRIMINAL INVESTIGATIONS

Multiple international investigations are underway involving named parties. These include agencies in the UK, Switzerland, and Greece. No further adjudication is appropriate until these matters are concluded.

V. STRUCTURAL CORRUPTION OF THE LOS ANGELES COURT

Tom Girardi, now disgraced, personally authored the \$900M judgment against me while under federal investigation. Over 150 bar complaints against him went unaddressed. This Court has become a nexus of judicial corruption, as reported by the LA Times and confirmed by the California State Bar's own audit.

PRAYER FOR RELIEF

I respectfully request that this Court:

1. STAY all proceedings in Case No. 20STCV37498 and related matters.
2. STRIKE my name from all litigation arising from the Alpha Nero case.
3. VACATE any judgments entered against me pursuant to fraud and coercion.
4. REFER attorneys and court officers for criminal investigation.
5. ENJOIN any further enforcement actions pending resolution of sovereign and criminal matters.

This motion is not discretionary. It is compelled by legal precedent, constitutional protections, and this Court's obligation to protect against abuse.
