The Claimant respectfully tenders herewith a Declaration and Exhibits of Support in the above-captioned matter, for the attention of the Honourable Justice Rene Williams.

1. Purpose of Submission

This filing sets out sworn testimony and corroborating exhibits evidencing a consistent pattern of judicial suppression, media manipulation, and coordinated misconduct by executives, attorneys, financial institutions, and affiliated parties, herein described as the “ Hollywood Media Cartel. ”

2. Sovereign Dimension

The amended action is styled “ Antigua vs. The Hollywood Media Cartel ” because the issues at bar directly impact the people and sovereign institutions of Antigua & Barbuda. The cartel ’ s coordinated activities have obstructed justice, interfered with governance, and sought to destabilize lawful proceedings in this jurisdiction.

3. Parallel Proceedings

This matter proceeds in parallel with related litigation before the High Court of Justice, King ’ s Bench Division, London (Case No. KB-2025-001991), and is cross-referenced to RICO filings in the United States.

4. Exhibits of Support

Appended to this submission are Exhibits JD-1 through RC-1, together with related complaints and declarations, indexed for the Court ’ s convenience. These include sworn witness statements of assaults, corroboration of coercion and blackmail, and records of nefariously terminated lawsuits,

including the jailing of whistleblower Rovier Carrington.

5. Relief Requested

The Claimant respectfully requests that:

- The Declaration and attached Exhibits be entered into the record in full;
- The Court recognize that prior proceedings in the United States were not adjudicated on the merits, but were suppressed through procedural manipulation;
- Such evidence be considered in assessing the systemic pattern of obstruction and retaliation carried out by the Hollywood Media Cartel.

1. Identity of Declarant. I am the Claimant in this matter. I submit this Declaration to place before the Court the systematic abuse, corruption, and judicial manipulation uncovered through sworn witness statements and nefariously terminated lawsuits. I could and would testify competently to these facts if called.
2. Pattern: The Legal–Media Cartel. The evidence shows an interlocking enterprise — herein referred to as the Legal–Media Cartel — comprised of: (a) executives (including Brian Graden, Sumner Redstone, Brad Grey, Harvey Weinstein); (b) attorneys (including Stanton “ Larry ” Stein, Russ August & Kabat LLP, Loeb & Loeb LLP, Shearman & Sterling LLP); (c) judicial actors in Los Angeles and the Southern District of New York; and (d) media outlets (including Variety, The Hollywood Reporter, TMZ). This enterprise operated to commit and cover up sexual assaults and trafficking; blackmail victims with videotaped rapes; suppress claims before discovery via weaponized procedure; and retaliate against whistleblowers with imprisonment, sanctions, and smear campaigns.
3. Exhibits of Support. Filed herewith are Exhibits JD-1 through RC-1, which form a single evidentiary chain and corroborate one another: JD-1 John Doe — statutory rape (2005) at MTV Santa Monica by Brian Graden; drugging and filmed gang rape (2016) by Graden & attorney Larry Stein. MS-1 Mercedes Stanley — corroborates assaults on Rovier Carrington by Graden, Redstone, Grey, Weinstein; threats of blacklisting by Paramount ’ s Reno Logan. DJ-1 Daniel Jackson — eyewitness to Carrington ’ s traumatized, bleeding state after Graden ’ s assault (2006). AV-1 Alex Vega — attests to underage sex parties filmed by Ted Sun; Brad Grey ’ s assault of Carrington (2016). KC-1 Keenan Carter — coercion at Paramount; Redstone/Grey/Weinstein assaults; underage parties with Stein present. JE-1 Jeremy Escherich — Carrington ’ s manager; saw aftermath of Grey ’ s violent assault at the Beverly Hilton; confirms Graden ’ s earlier rapes. RC-1 Rovier Carrington — his Declarations & Complaints, showing derailment of lawsuits and jailing for contempt.
4. Nefariously Shut Down Lawsuits. The attached complaints show the same pattern: (a) Carrington v.

Graden et al., SDNY 18-cv-04609 (KPF). The Court applied Individual Rules over Federal Rules; discovery never opened against defendants while unilateral discovery was imposed on Carrington; case dismissed with prejudice without responsive pleadings; the Court acknowledged it would never reach the merits. (b) Permanent Injunction, SDNY (Sept. 11, 2020). After Carrington noticed intent to refile in California, a permanent injunction barred refiling — functioning as a gag order. (c) Los Angeles Superior Court Protective Orders (2019–2020). TRO sought against Brian Graden following threats; opposing counsel alleged call “spoofing”; matter dismissed with prejudice; sanctions noticed. (d) Carrington v. Weinstein et al., C.D. Cal. 2:20-cv-09825-VAP-JC. Complaint pled sexual assaults by Graden, Grey, Weinstein, Redstone and collusion in SDNY; case terminated before discovery.

5. Judicial Weaponization. Across fora, valid complaints were terminated at the pleading stage; Carrington was jailed and labeled vexatious; courts functioned as conduits for CBS/Viacom attorneys to invert victim and accused, erase evidence, and protect perpetrators.

6. Media Manipulation. Variety and The Hollywood Reporter confirmed evidence privately yet withheld publication or ran defamatory spin; TMZ amplified narratives discrediting victims; this served the Cartel ’ s objective of stigmatizing whistleblowers and chilling reports to law enforcement.

7. Conclusion. The Exhibits and complaints demonstrate sabotage by coordinated actors — executives, attorneys, judges, and media — amounting to a racketeering enterprise, obstruction of justice, and retaliation against whistleblowers. I respectfully request entry of these Exhibits into the record and recognition that prior cases were not adjudicated on the merits but suppressed through procedural manipulation.

I declare under penalty of perjury under the laws of Antigua and Barbuda that the foregoing is true and correct.
