**AFFIDAVIT OF ALKIVIADES DAVID IN SUPPORT OF EXHIBIT “AD-1”**

**I. INTRODUCTION**

I, Alkiviades David, of SwissX Island, St. John’s, Antigua and Barbuda, British citizen and principal of the SwissX Sovereign Wealth Fund, do hereby make oath and say as follows:

I am the First Claimant in these proceedings and submit this affidavit in support of my RICO-based civil claim arising under the laws of Antigua and Barbuda, including the Civil Asset Recovery Act, the Proceeds of Crime Act, and all other relevant anti-corruption and racketeering statutes.

The facts set out herein are true to the best of my knowledge and belief. Where I refer to matters outside my own knowledge, I rely on documents and sworn affidavits provided to me, which I believe to be true.

**II. DESCRIPTION OF EXHIBIT “AD-1”**

Annexed hereto and marked “Exhibit AD-1” is a 242-page dossier titled “Evidence Master: Compiled by Alki David & Barbara Burke (Malibu, CA)”, which I incorporate by reference as if fully set out herein.

This dossier contains substantial documentary evidence of a transnational criminal conspiracy involving attorneys and law firms based in the United States, Switzerland, and elsewhere, whose coordinated activities have:

- Resulted in the destruction of my businesses;

- Caused direct harm to Antigua-based companies and trust assets, including SwissX Island and the SwissX Sovereign Wealth Fund;
- Violated the criminal and civil statutes of Antigua and Barbuda, the United States, and the Swiss Confederation.

### **III. LEGAL SIGNIFICANCE OF THE EXHIBIT**

The exhibit sets forth, in detailed chronological and evidentiary form, predicate acts of racketeering as defined under international and local law, including:

- Wire fraud, mail fraud, and bribery;
- Obstruction of justice and witness tampering;
- Fabricated evidence and forged documents submitted in judicial proceedings;
- False claims and attempted enforcement of illegal foreign judgments, including punitive damages not recognized under Swiss law;
- Targeted extortion and defamatory press campaigns aimed at coercing settlements or bankruptcy.

The exhibit includes court records, text messages, Swiss legal filings, sworn statements, and verified documentation evidencing harm and conspiracy.

### **IV. NEXUS TO ANTIGUA & BARBUDA**

These acts have caused direct injury to Antiguan companies including:

- SwissX Group Antigua and its franchise operations;
- The SwissX Sovereign Wealth Fund, which holds assets on behalf of the indigenous citizens of Antigua and Barbuda;
- Government partnerships, tax concessions, and regenerative projects backed by the Global Bank of Commerce and the Government of Antigua and Barbuda.

The conspirators' attempts to enforce these judgments against real estate, IP assets, and biodiesel contracts under Antiguan jurisdiction amount to sovereign interference, financial sabotage, and attempted fraudulent enforcement of foreign judgments in a Small Island Developing State (SIDS).

### **V. PRAYER FOR RELIEF**

I respectfully request that this Honourable Court:

- Admit Exhibit AD-1 into the evidentiary record of these proceedings;
- Take judicial notice of its contents pursuant to the Evidence Act of Antigua and Barbuda;

- Permit further reference to Exhibit AD-1 in subsequent filings, affidavits, and oral arguments as may be required.

I further declare that this affidavit and Exhibit AD-1 are submitted in good faith and in accordance with the procedural and evidentiary rules of this Honourable Court.
